## Quarterly Labour Cost Survey (QLCS) Third quarter of 2009

### Main results

- The labour cost for companies increases 3.3% in the third quarter, as compared with the same period in 2008, standing at 2,428.69 euros. This growth rate is the lowest since the fourth quarter of 2005.

– The wage cost per worker per month, increases 3.1%, reaching an average of 1,776.25 euros, whereas other costs increase 3.9%, standing at 652.63 euros per worker per month.

- The effective day worked decreases 0.8%. Regarding the agreed working day of 35.8 hours per week, 7.4 working hours are lost weekly this quarter, on average, five of which are for holidays.

- The labour cost per effective hour worked increases 4.2%.

- The process of implementing the new National Classification of Economic Activities (CNAE-2009) will not be completed until towards the end of this year, therefore **during the** four quarters of the current year, the data provided by the survey will be of a provisional nature

### Labour cost by component

The labour cost per worker per month reached 2,428.69 euros for the third quarter of 2009, indicating an increase of 3.3% as compared with the same period the previous year. In the third quarter of 2008, the labour cost grew at a rate of 4.8%.



Of the total cost per worker per month incurred by an employer for the use of the work factor, 1,776.25 euros corresponded to wages, and 569.33 euros to Obligatory Social Security contributions. The remainder corresponded to compensation for dismissal, social benefits, etc.

The main component of the total cost was the wage cost. The wage cost, which comprises base salary, salary supplements, overtime payments, extraordinary payments and delayed payments, measured in gross terms, increased 3.1% in the interannual rate, rising from 1,722.38 to 1,776.25 euros per worker per month. If the variable factor is excluded from wages (extraordinary and delayed payments), the ordinary wage cost is obtained, which increased 3.0%.

Other costs (non-wage costs) increased 3.9%. Their main component, Obligatory Social Security contributions, grew 2.8%. Within the increase in non-wage payments, worth noting, in absolute terms, was the increase in compensation for dismissal and in direct corporate contributions (benefits complementary to Social Security, paid by the employer).

The labour cost per hour grew 4.2%. This increase, greater than that of the cost per worker, was due to a decrease of 0.8% in the number of hours effectively worked.

### Labour cost by economic sector

*Construction* was the sector presenting the greatest increase in total labour cost, with growth in all its components: ordinary wages, extraordinary payments and within other costs, in particular, compensation for dismissal and end of contract payouts.

*Industry* presented the smallest growth in wage cost, mainly as a result of the high number of employment regulation orders registered in the sector. Regarding other costs, this sector presented the greatest increases in compensation for dismissal and direct corporate contributions.

In the *Services* sector, also worth noting was the increase in other costs, due to compensation for dismissal and direct corporate contributions.


### Labour cost by economic sector

### Labour cost by Autonomous Community

The labour cost in País Vasco and Comunidad de Madrid surpassed the national average by more than 300 euros. In Extremadura and Canarias, said labour cost was the same amount lower than the national average.

Considering the interannual growth of the cost, Región de Murcia, Extremadura and Cataluña presented the highest rates, whilst País Vasco, Cantabria and Cataluña registered the smallest increases.




### Working time

During the third quarter of 2009, the average agreed working week, considering full-time and part-time together, was 35.8 hours. Of these, an average of 7.4 hours were lost per week, most of which were due to public holidays.

After adding overtime and subtracting hours lost, the working week was reduced to 28.6 effective hours worked.

#### Hours not worked



According to the **type of working day**, the wage difference between full- and part-time workers was 4.59 euros per hour (14.73 euros/hour for full-time and 10.14 euros/hour for part-time). Regarding time worked, full-time workers practically doubled the effective hours worked by part-time workers (30.7 hours for full-time workers as compared with 17.0 hours for part-time workers).
