# Quarterly Labour Cost Survey (QLCS) Third quarter of 2012


#### Main results

- **The labour cost** of companies **decreases 0.1%** in the third quarter of 2012, as compared with the same period of 2012, standing at **2,455.49 euros**.
- The wage cost per worker per month increases 0.3%, reaching 1,805.63 euros on average. In turn, other costs decrease 0.9%, standing at 649.86 euros per worker per month.
- -The working day remains the same level than the previous year. This quarter, 7.2 working hours per week are lost on average, 80% of which are due to holidays taken and public holidays.
- The **labour cost per effective hour worked** remains unchanged as compared with the third quarter of 2011.

### Labour cost by component

The labour cost per worker per month reached 2,455.49 euros for the third quarter of 2012, indicating a decrease of 0.1%, as compared with the same period of 2011.

#### **Total labour cost. Annual variation rate**



Of the total cost per worker per month incurred by an employer for the use of the work factor, 1,805.63 euros corresponded to wages and 572.25 euros to obligatory Social Security contributions. The remainder corresponded to compensation for dismissal, social benefits, etc.

The wage cost, which comprised base salary, wage supplements, overtime payments, extraordinary payments and delayed payments, measured in gross terms, increased 0.3% in annual rate, stands from 1,800.84 to 1,805.63 euros per worker per month. If the variable factor is excluded from wages (extraordinary and delayed payments), the ordinary wage cost is obtained, which increased 0.2%.

Other costs (non-wage costs) decreased 0.9%. Their main component, obligatory Social Security contributions, decreased 0.4%, whereas non-wage payments decreased 9.3%, worth noting the increase of compensation for dismissal and other non-wage payment (contract termination indemnities, compensation payment, wear and tear of tools, work clothes, personal selection, etc.).

The labour cost per hour remained the same level than the last year.

### Labour cost by economic sector

*Industry* and *Construction* presented increases in total labour cost and in their main components. In both sectors worth noting the increase in total wage. *Industry* registered the greatest increase in other costs, specially dismissal and compensation for end of contract.

In turn, the sector *Services* decreased its labour costs due to the maintenance of the total wage cost and the decrease of other costs, specially compensation for dismissal.

The increase in other costs was due highlighting compensation for dismissal.

In worth noting the decrease in total labor cost due to the drop in total wage cost, bonuses and other costs, specially.





By activity sections, was observed that the increase of the labour cost was higher in sections D, Electricity, gas, steam and air conditioning supply, H, Transport, storage and communications and B, Extractive Industries. Conversely in sections P, Education, L, Real estate activities and I, Accommodation, the labour cost registered the most important decreases.

#### Labour cost per worker per month






### **Labour cost by Autonomous Community**

The labour cost in Comunidad de Madrid and País Vasco surpassed the national average by more than 300 euros. In Extremadura and Canarias said labour cost was the same amount lower than the national average.

Considering the interannual growth of this cost, Cataluña, Comunidad de Madrid and Comunitat Valenciana presented the highest rates. In turn, Cantabria, Galicia and Principado de Asturias registered the lowest decreases.

## Working time

70.2%

During the third quarter of 2012, the average agreed working week, considering full-time and part-time together, was 35.0 hours. Of these, an average of 7.2 hours were lost per week, most of which were due to holidays.

After adding overtime and subtracting hours lost, the working week was reduced to 28.0 effective hours worked.

According to the type of working day, the wage difference between full and part-time workers was 5.22 euros per hour (15.50 euros/hour for full-time and 10.28 euros/hour for part-time).

Regarding the time worked, full-time workers practically doubled the effective hours worked by part-time workers (30.6 hours for full-time workers as compared with 17.2 hours for parttime workers).



# Evolution of the quarterly rate <sup>1</sup>

To analyse the evolution of the quarterly rate, the ordinary labour cost was the variable that presented less seasonal variations. The variation in the third quarter, as compared with the second guarter of 2012, for the ordinary labour cost was 0.5%.
