
Quarterly Labour Cost Survey (QLCS) Fourth quarter of 2009

Main results

- The labour cost for companies increases 2.5% in the fourth quarter, as compared with the same period in 2008, standing at **2,649.13 euros**. This growth rate is the lowest since the third quarter of 2005.
- The wage cost per worker per month, increases 2.7%, whereas other costs increase 1.9%.
- The effective day worked decreases **2.4%**. Regarding the **agreed working day of 35.5** hours per week, **5.0** working hours are lost weekly this quarter on average.
- The labour cost per effective hour worked increases 5.1%.
- The process of implementing the new National Classification of Economic Activities (CNAE-2009) has concluded with the publication of the fourth quarter of 2009. Therefore, the data provided by the survey in 2009 is already final in nature.

Labour cost by component

The labour cost per worker per month reached 2,649.13 euros in the fourth quarter of 2009, indicating an increase of 2.5% as compared with the same period of 2008. **This growth rate was the lowest since the third quarter of 2005**.



Of the total cost per worker per month incurred by an employer for the use of the work factor, 1,993.15 euros corresponded to wages, and 567.89 euros to Obligatory Social Security contributions. The remainder corresponded to compensation for dismissal, social benefits, etc.

The main component responsible for the growth in the total cost was the wage cost. The wage cost, which comprises base salary, salary supplements, overtime payments, extraordinary payments and delayed payments, measured in gross terms, increased 2.7% in the interannual rate. If the variable factor is excluded from the wages (extraordinary and delayed payments), the ordinary wage cost is obtained, which increased 2.2%.

Other costs increased 1.9%. Their main component, Obligatory Social Security contributions, grew 2.6%. Worth noting was the decrease in non-wage payments, due to the fact that the increase in payments for partial unemployment and in direct corporate contributions (benefits complementary to Social Security, paid by the employer), did not compensate for the drop experienced by compensation for dismissal.

In turn, the labour cost per hour grew 5.1%. This increase, greater than that of the cost per worker, was due to a decrease of 2.4% in the number of hours effectively worked.

Labour cost by economic sector

Construction was the sector presenting the greatest increase in total labour cost. Worth noting in this sector was the growth in ordinary wages, extraordinary payments and delayed payments. However, other costs recorded less growth than in other sectors, due to the decrease in compensation for dismissal.

The growth in total wage cost was similar in *Industry* and *Services*. *Industry* presented the least growth in ordinary wages, mainly due to the high number of employment regulation files registered in this sector.

Regarding other costs, Industry presented the greatest increases in compensation for dismissal and direct corporate contributions. In the Services sector, compensation for dismissal dropped to a lesser extent than in Construction.

Labour cost by Autonomous Community

The labour cost in Comunidad de Madrid and País Vasco surpassed the national average by more than 300 euros. In Canarias, Extremadura and Galicia, said labour cost was the same amount lower than the national average.

Considering the interannual growth of the cost, Región de Murcia, Principado de Asturias and Extremadura presented the highest rates, whilst Illes Balears, Cantabria and Canarias registered the smallest increases.




Working time

During the fourth quarter of 2009, the average agreed working week, considering full-time and part-time together, was 35.5 hours. Of these, an average of 5.0 hours were lost per week, most of which were due to holidays and public holidays.

After adding overtime and subtracting hours lost, the working week was reduced to 30.5 effective hours worked.

Hours not worked



According to the **type of working day**, the wage difference between full- and part-time workers was 4.82 euros per hour (15.48 euros/hour for full-time and 10.66 euros/hour for part-time).

Regarding the time worked, full-time workers practically doubled the effective hours worked by part-time workers (33.3 hours per week for full-time workers as compared with 17.1 hours for part-time workers).
