

Statistics on Transfer of Property Rights

Year 2012. *Provisional data*


In 2012, the number of property transfers is 1,598,359, 3.0% less than in the previous year

The annual rate of merchanting of dwellings decreases 11.3%

The INE publishes for the first time, independently, an annual summary with the performance of the Transfer of Property Rights. The information used is based on the annual data of 2012, as well as on the performance of the last five years.

The number of property transfers **recorded in the land registries, from public deeds previously registered**, was 1,598,359 in 2012, that is, 3.0% less than in 2011.

In the case of registered merchantings of property, the number of transfers was 698,226, representing an annual decrease of 8.6%, as compared with the previous year.

¹ "Other titles" includes land consolidation, horizontal divisions, joint ventures or mixtures of several titles transmission, transmissions without title of acquisition, Nonrecourse debt, foreclosures and court awards.

Merchantings recorded in the land registries

85.0% of the registered merchantings in 2012 corresponded to urban properties and 15.0% to rustic properties. Among the urban properties, 53.7% were merchantings of dwellings.


The number of merchantings of rustic properties increased 0.9% in the annual rate in 2012, and that of urban properties decreased 10.1%. Within the later, merchantings of dwellings decreased 11.3%.

Annual variation



By the analysis of the annual rate performance of the number of merchantings of dwellings in the last five years, it can be observed that the -11.3% rate registered in 2012 was 6.8 points less negative than that registered in the previous year.

Registered merchantings of dwellings, by protection system and status

88.0% of transfers of dwellings by merchanting in 2012 were free housing, and 12.0% were protected housing. In annual terms, the number of transfers of free dwellings by merchanting decreased 10.0%, and that of protected housing decreased 20.0%, as compared with 2011.



49.5% of the dwellings transferred by merchanting in 2012 were new, and 50.5% were used.

The number of transactions on new dwellings increased 9.3%, and the number of used dwellings decreased 13.2%, as compared with 2011.

Geographical distribution

In 2012, the total number of property transfers recorded in the land registries per 100,000 inhabitants³ reached its highest value in the Autonomous Communities of Castilla y León (7,185), La Rioja (6,841) and Castilla-La Mancha (6,717).

Likewise, the only Autonomous Communities showing positive annual variation rates in the number of property transfers were Comunitat Valenciana (3.5%) and Castilla-La Mancha (0.1%). In turn, those showing the highest decreases were Cantabria (-11.4%) and Galicia (-11.1%).

Number of registered property transfers, by autonomous cities and communities



By registered merchantings of dwellings, the Autonomous Communities with the highest number of transfers per 100,000 inhabitants³ were La Rioja (1,172) and Comunitat Valenciana (1,130). In turn, the lowest number is registered in Galicia (633) and País Vasco (688).

³ This data was calculated from the revision of the figures of the Municipal Register for the year 2011. Only the population aged 18 to 84 years old was considered.

The only Autonomous Communities showing the highest annual variation rate in the merchanting of dwellings was Castilla-La Mancha (2.7%). In turn, those showing the highest decreases were Cantabria (-33.8%), País Vasco (-20.6%) and Comunidad de Madrid (-18.6%).
