Statistics on Transfer of Property Rights (STPR)
January 2016. *Provisional data*


In January, the number of property transfers registered is 136,771 properties, that is, 2.8% less than in the same month of the previous year

The merchenting of registered dwellings decreases by 2.9%, as compared with January of 2015

The number of property transfers recorded in the land registries (from public deeds previously registered) was 136,771 in January, that is, 2.8% less than in the same month of 2015.

Regarding the merchenting of registered properties, the number of transfers was 66,959, with a 4.1% annual decrease.

¹ "Other titles" includes land consolidation, horizontal divisions, joint ventures or mixtures of several titles transmission, transmissions without title of acquisition, non recourse debt, foreclosures and court awards.

Merchanting recorded in the land registries

84.4% of the registered merchanting in January corresponded to urban properties and 15.6% to rustic properties. Among the urban properties, 57.4% were merchanting of dwellings.

In January, the number of merchanting of rustic properties decreased by 6.2% in the annual rate, and that of urban properties decreased 3.7%. Within the latter, merchanting of dwellings recorded an annual decrease of 2.9%.



Evolution of the monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation in the number of merchanting of dwellings between the months of December and January of the last five years. In 2016, the monthly rate was 17.3%, that is, 11.7 points less than that of the previous year.

Registered merchanting on dwellings, by protection system and status

89.7% of transfers of dwellings by merchanting in January were free housing, and 10.3% were protected housing.

In annual terms, the number of transfers of free dwellings by merchanting decreased by 2.0%, and that of protected dwellings decreased by 9.9%.


19.5% of the dwellings transferred by merchanting in January were new, and 80.5% were used.

The number of transactions on new dwellings decreased by 28.9% as compared to January 2015. In turn, the number of used dwellings increased by 6.6%.

Results by Autonomous Community

In January 2016, the total number of property transfers recorded in the land registries per 100,000 inhabitants¹ reached its highest value in Aragón (626), Castilla y León (593) and La Rioja (570).

Extremadura (20.2%) registered the greatest annual variations.

In turn, the Autonomous Communities that registered the lowest annual rates were Galicia (-29.2%) and La Rioja (-19.2%).


Regarding the merchanting on registered dwellings, the Autonomous Communities with the highest number of transfers per 100,000 inhabitants² were Comunitat Valenciana (113) and Illes Balears (108).

²This data was calculated from the provisional data of the Population Figures on 1 January 2015. Only the population aged 18 to 84 years old was considered

The Autonomous Community showing the greatest annual variation rate in the merchandising of dwellings in January were Comunidad Foral de Navarra (18.4%) and Castilla–La Mancha (17.9%).

In turn, La Rioja (–25.3%), and Canarias (–16.2%) registered the most negative annual rates.
