

**Statistics on Transfer of Property Rights (STPR)**  
February 2016. *Provisional data*


**In February, the number of property transfers registered is 154,386 properties, that is, 5.3% more than in the same month of the previous year**

**The merchanting of registered dwellings increases by 15.8%, as compared with February of 2015**

The number of property transfers **recorded in the land registries (from public deeds previously registered)** was 154,386 in February, that is, 5.3% more than in the same month of 2015.

Regarding the merchanting of registered properties, the number of transfers was 72,197, with a 10.8% annual increase.

## Merchanting recorded in the land registries

84.9% of the registered merchanting in January corresponded to urban properties and 15.1% to rustic properties. Among the urban properties, 56.7% were merchanting of dwellings.

In February, the number of merchanting of rustic properties decreased by 4.2% in the annual rate, while that of urban properties increased 13.9%. Within the latter, merchanting of dwellings recorded an annual increase of 15.8%.



### Evolution of the monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation in the number of merchanting of dwellings between the months of January and February of the last five years. In 2016, the monthly rate was 7.3%, that is, 17.3 points less than that of the previous year and the only positive one of the period considered.

## Registered merchanting on dwellings, by protection system and status

89.2% of transfers of dwellings by merchanting in February were free housing, and 10.8% were protected housing.

In annual terms, the number of transfers of free dwellings by merchanting increased by 16.0%, and that of protected dwellings increased by 14.3%.


22.5% of the dwellings transferred by merchanting in February were new, and 77.5% were used.

The number of transactions on new dwellings decreased by 0.2% as compared to February 2015. In turn, the number of used dwellings increased by 21.4%.

## Results by Autonomous Community

In February 2016, the total number of property transfers recorded in the land registries per 100,000 inhabitants<sup>1</sup> reached its highest value in La Rioja (746) and Aragón (723).

Extremadura (29.6%) and Illes Balears (26.4%) registered the greatest annual variations.

In turn, Andalucía (-10.6%) and Galicia (-1.0%) are the only ones with negative rates.


Regarding the merchanting on registered dwellings, the Autonomous Communities with the highest number of transfers per 100,000 inhabitants<sup>2</sup> were Comunitat Valenciana (133) and Illes Balears (124).

<sup>1</sup>This data was calculated from the provisional data of the Population Figures on 1 January 2015. Only the population aged 18 to 84 years old was considered

The Autonomous Community showing the greatest annual variation rate in the merchanting of dwellings in February were País Vasco (50.3%), Principado de Asturias (40.0%) and Cantabria (38.9%).

In turn, La Rioja (-8.6%), and Castilla y León (-3.9%) registered negative annual rates.
