Statistics on Transfer of Property Rights (STPR)
March 2016. *Provisional data*


In March, the number of property transfers registered is 143,478 properties, that is, 0.3% less than in the same month of the previous year

The merchanting of registered dwellings increases by 16.8%, as compared with March of 2015

The number of property transfers **recorded in the land registries (from public deeds previously registered)** was 143,478 in March, that is, 0.3% less than in the same month of 2015.

Regarding the merchanting of registered properties, the number of transfers was 66,645, with a 8.5% annual increase.

¹ "Other titles" includes land consolidation, horizontal divisions, joint ventures or mixtures of several titles transmission, transmissions without title of acquisition, non recourse debt, foreclosures and court awards.

Merchanting recorded in the land registries

83.4% of the registered merchanting in March corresponded to urban properties and 16.8% to rustic properties. Among the urban properties, 57.4% were merchanting of dwellings.

In February, the number of merchanting of rustic properties decreased by 5.2% in the annual rate, while that of urban properties increased 11.7%. Within the latter, merchanting of dwellings recorded an annual increase of 16.8%.



Evolution of the monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation in the number of merchanting of dwellings between the months of February and March of the last five years. In 2016, the monthly rate was -8.2%, that is, 0.8 points more than that of the previous year.

Registered merchanting on dwellings, by protection system and status

89.2% of transfers of dwellings by merchanting in March were free housing, and 10.8% were protected housing.

In annual terms, the number of transfers of free dwellings by merchanting increased by 16.5%, and that of protected dwellings increased by 18.9%.


19.3% of the dwellings transferred by merchanting in March were new, and 80.7% were used.

The number of transactions on new dwellings decreased by 6.6% as compared to March 2015. In turn, the number of used dwellings increased by 24.2%.

Results by Autonomous Community

In March 2016, the total number of property transfers recorded in the land registries per 100,000 inhabitants¹ reached its highest value in Aragón (660), Castilla y León (610) and La Rioja (609).

Canarias (19.8%) and Aragón (13.3%) registered the greatest annual variations.

In turn, the Autonomous Communities that registered the lowest annual rates were Galicia (-23.3%) and La Rioja (-10.7%).


Regarding the merchanting on registered dwellings, the Autonomous Communities with the highest number of transfers per 100,000 inhabitants² were Canarias (127) and Illes Balears (108).

¹This data was calculated from the provisional data of the Population Figures on 1 July 2015. Only the population aged 18 to 84 years old was considered

The Autonomous Community showing the greatest annual variation rate in the merchanting of dwellings in March were Canarias (52.7%) and Extremadura (34.6%).

In turn, La Rioja and Galicia (both with -3.1%) registered negative annual rates.
