Statistics on Transfer of Property Rights (STPR) March 2021. Provisional data

**In March, 200,774 properties are registered in the land registers,
42.3% more than in the same month of 2020**


**Registered home sales increased 32.4% in the annual rate and by
9.6% in the monthly rate**

The number of property transfers recorded in the land registers (from public deeds previously registered) was 200,774 in March, that is, 42.3% more than in the same month of 2020.

Regarding registered property sales, the number of transfers was 99,410, with an annual increase of 37.5%.

¹The heading "Other titles" includes the following items: land consolidation, horizontal divisions, joint operations or mixtures of several transfer titles, transfers without title of acquisition, dation in payment, foreclosures and court orders.

Sales recorded in land registers

85.2% of registered sales in March corresponded to urban properties and 14.8% to rustic properties. Among urban properties, 55.9% were housing sales.

In March, the number of rustic property sales increased by 45.1% in the annual rate, while there was a 36.2% decrease for urban properties. Within the latter, housing sales recorded an annual increase of 32.4%.



Trend in monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation in the number of housing sales between the months of February and March in the last five years. In 2021, the monthly rate was 9.6%, that is, 30.3 points more than the previous year.

Registered housing sales, by protection system and status

91.3% of dwellings transferred by sale in March were free-market dwellings and 8.7% were protected dwellings.

In annual terms, the number of free dwellings transferred by sale increased by 32.9%, and that of protected dwellings by 28.0%.

21.4% of the dwellings transferred by sale in March were new, and 78.6% were used.

The number of new home transactions rose 52.6% compared to March 2020 and that of used homes 27.8%.



Results by Autonomous Community

In March, the total number of property transfers recorded in the land registries per 100,000 inhabitants¹ was highest in La Rioja (1,053), Castilla y León (849) and Castilla-La Mancha (762).

La Rioja (97.2%), Cantabria (74.3%) and Comunidad de Madrid (66.5%) registered the highest annual variation rates.

The only autonomous community with a negative variation rate was Canarias (-2.7%). In turn, Andalucía (34.3%) and Comunitat Valenciana (35.5%) registered the lowest increases.

Considering registered housing sales, the Autonomous Communities with the highest number of transfers per 100,000 inhabitants¹ were Comunitat Valenciana (153), La Rioja (152) Cantabria (145).



¹ This data has been calculated based on the provisional results of the population figures as at 01 July 2019. Only the population aged 18 to 84 years old is considered in these figures.

The Autonomous Communities that registered the greatest annual increases in the number of housing sales in March were Comunidad de Madrid (59.2%), Cantabria (56.9%) and La Rioja (55.6%).

The only autonomous community with a negative variation rate was Illes Balears (-3.0%). On the other hand, Canarias (2.7%) and Región de Murcia (14.0%) registered the lowest increases.

Revision and updating of data

Data for 2021 is provisional and will be reviewed when the data for the same period of the next year is published. In other words, when the data for February 2022 is published, the finalized data for the same month in 2021 will be released.

Methodological note

The Statistics on Transfer of Property Rights provide information on the number of rights on transfers of property during the reference month, on a national level, by province and Autonomous Community.

All information on transfers of property is taken from the information contained in the Land Registers for the whole country, by virtue of a partnership agreement signed in 2004 by both institutions.

Type of survey: continuous on a monthly basis

Population scope: registrations of transfers of property rights in the land registers

Geographical scope: the entire national territory, by Autonomous Community and provinces

Reference period for the results: the calendar month

Reference period for the information: the calendar month

Classification: sale, donation, inheritance, exchange and other property titles, of rustic and urban properties (dwellings, plots and other urban properties)

Collection method: administrative registers from Association of property and Mercantile registers of Spain
