Statistics on Transfer of Property Rights (STPR) June 2019. Provisional data

**In June 166,094 properties were registered in the land registers,
3.9% less than in the same month of the previous year**


**Registered housing sales decreased by 9.0%, as compared with
June 2018**

The number of property transfers recorded in the land registers (from public deeds previously registered) was 166,094 in June, that is, 3.9% less than in the same month of 2018.

Regarding registered property sales, the number of transfers was 81,218, with a 7.7% annual decrease.

¹The heading "Other titles" includes the following items: land consolidation, horizontal divisions, joint operations or mixtures of several transfer titles, transfers without title of acquisition, dation in payment, foreclosures and court orders.

Sales recorded in land registers

In June, 86.9% of registered sales corresponded to urban properties and 13.1% to rustic properties. Among urban properties, 58.1% were housing sales.

In June, the number of merchanting of rustic properties decreased by 10.7% in the annual rate, while that of urban properties did so by 7.2%. Within the latter, housing sales recorded an annual decrease of 9.0%.



Trend in monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation in the number of housing sales between the months of May and June in the last five years. In 2019, the monthly rate was -13.9%, 9.5 points less than the previous year.

Registered housing sales, by protection system and status

In June, 90.9% of dwellings transferred by sale were free-market dwellings and 9.1% were protected dwellings.

In annual terms, the number of transfers of free dwellings by merchanting decreased by 8.5%, and that of protected dwellings did so by 13.6%.

In June, 17.6% of dwellings transferred by sale were new and 82.4% were used.

The number of transactions on new dwellings decreased 7.8%, while that of used dwellings decreased 9.2% as compared with June 2018.



Results by Autonomous Community

In June, the total number of property transfers recorded in the land registries per 100,000 inhabitants¹ reached its highest values in La Rioja (713), Aragón (670) and Castilla y León (661).

Aragón (3.7%), Galicia (2.4%) and La Rioja (0.4%) registered the highest annual variation rates.

In turn, País Vasco (-13.1%), Illes Balears (-12.4%) and Extremadura (-9.2%) registered the lowest annual rates.

Regarding registered housing sales, the Autonomous Communities with the highest number of transfers per 100,000 inhabitants¹ were Comunitat Valenciana (159), Región de Murcia (128) and Andalucía (123).



¹ This data have been calculated based on the provisional results of the population figures as at 01 January 2019. Only the population aged 18 to 84 years old is considered in these figures.

The Autonomous Communities that registered the greatest annual increases in the number of merchanting of dwellings in June were Castilla-La Mancha(9.2%), Región de Murcia (7.2%) and Galicia (4.5%).

In turn, Canarias (-22.5%), Illes Balears (-17.4%) and Aragón (-13.9%) registered the most negative annual variation rates in June.

Revision and updating of data

Data for 2019 are provisional and will be reviewed when the data for the same period of the next year are published. In other words, when the data for June 2020 are published, the final data for the same month of 2019 will be disseminated.

Methodological note

The Statistics on Transfer of Property Rights provide information on the number of rights on transfers of property during the reference month, on a national level, by province and Autonomous Community.

All information on transfers of property is taken from the information contained in the Land Registers for the whole country, by virtue of a partnership agreement signed in 2004 by both institutions.

Type of survey: continuous on a monthly basis

Population scope: registrations of transfers of property rights in the land registers

Geographical scope: the entire national territory, by Autonomous Community and provinces

Reference period of the results: the calendar month

Reference period of the information: the calendar month

Classification: sale, donation, inheritance, exchange and other property titles, of rustic and urban properties (dwellings, plots and other urban properties)

Collection method: administrative registers from Association of property and Mercantile registers of Spain
