Statistics on Transfer of Property Rights (STPR) July 2023. Provisional data

**In July, 170,109 properties were entered in the property registers,
4.7% fewer than in the same month of the previous year**


**Registered housing sales decreased by 10.5% as compared with
July 2022**

The number of property transfers recorded in the land registers (from previously registered public deeds) in July was 170,109, that is, 4.7% fewer than in the same month in 2022.

As for registered property sales, the number of transfers was 92,262, with an 8.7% annual decrease.

¹The heading "Other titles" includes the following items: land consolidation, horizontal divisions, joint operations or mixtures of several transfer titles, transfers without title of acquisition, dation in payment, foreclosures and court orders.

Sales recorded in land registers

87.8% of registered sales in July were urban properties and 12.2% were rural properties. Among urban properties, 59.6% were housing sales.

In July, the number of rural property sales decreased by 6.0% in the annual rate, while there was a 9.1% decrease for urban properties. Within the latter, housing sales recorded an annual decrease of 10.5%.



Trend in monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation in the number of housing sales between the months of June and July over the last five years. In 2023, the monthly rate was -10.5%; that is, 4.1 points less than the previous year.

Registered housing sales, by social housing system and status

92.7% of housing transfers by sale in July were unrestricted housing, and 7.3% social housing.

In annual terms, the number of transfers of free dwellings by sale decreased by 10.0%, and that of protected dwellings did so by 16.5%.

17.1% of housing transfers by sale in July were new, and 82.9% were used.

The number of new home transactions declined 7.4% compared to July 2022 and that of used homes 11.2%.



The number of housing sales between natural persons in July was 33,068, that is, 12.4% fewer than in the same month in 2022.

Results by Autonomous Community

In July, the total number of property transfers recorded in the land registries per 100,000 inhabitants¹ reached its highest values in Castilla y León (711), Castilla-La Mancha (629) and Aragón (624).

Extremadura (8.1%), Castilla y León and País Vasco (both 0.2%) registered the highest annual variation rates.

In turn, Comunidad Foral de Navarra (-23.7%), La Rioja (-16.0%) and Illes Balears (-15.4%) registered the lowest annual rates.

With regard to registered housing sales, the Autonomous Communities with the highest number of transfers per 100,000 inhabitants¹ were Comunitat Valenciana (189), Región de Murcia (149) and Andalucía (144).



¹ These data have been calculated based on the provisional results of the population figures as of 01 July 2023. Only the population aged 18 to 84 years old is considered in these figures.

The Autonomous Communities that registered the greatest annual increases in the number of housing sales in July were Extremadura (5.2%), Principado de Asturias (3.8%) and Región de Murcia (0.2%).

In turn, Galicia (-22.8%), Canarias (-18.2%) and Comunidad Foral de Navarra (-17.2%) registered the highest decreases.

Revision and updating of data

Data for 2023 is provisional and will be reviewed when the data for the same period of the next year is published. In other words, when the data for July 2024 are published, the final data for the same month in 2023 will be disseminated.

Coinciding with today's publication, the INE has updated the data for the Transfer of Property Rights series for the months of July to December 2022, as well as the annual data for 2022. The results are available at INEBase.

Methodological note

The Statistics on Transfer of Property Rights provide information on the number of rights on transfers of property during the reference month, nationally, by province and Autonomous Community.

All information on transfers of property is taken from the information contained in the Land Registers for the whole country, on the basis of a partnership agreement signed in 2004 by both institutions. <http://www.registradores.org/portal-estadistico-registral/>

Type of survey: continuous on a monthly basis

Population scope: registrations of transfers of property rights in the land registers

Geographical scope: the entire national territory, by Autonomous Community and provinces

Reference period of the results: the calendar month

Reference period of the information: the calendar month

Classification: sale, donation, inheritance, exchange and other property titles, of rural and urban properties (dwellings, plots and other urban properties)

Collection method: administrative registers from Association of Land and Mercantile Registers of Spain
