**Statistics on Transfer of Property Rights (STPR)**  
August 2019. Provisional data

**In August, 150,464 properties are registered in the land registers, 5.1% less than in the same month of the previous year**


**Registered housing sales decreased by 21.1%, as compared with August 2018**

The number of property transfers recorded in the land registers (from public deeds previously registered) was 150,464 in August, that is, 5.1% less than in the same month of 2018.

Regarding registered property sales, the number of transfers was 73,010, with a 15.7% annual decrease.

<sup>1</sup>The heading "Other titles" includes the following items: land consolidation, horizontal divisions, joint operations or mixtures of several transfer titles, transfers without title of acquisition, dation in payment, foreclosures and court orders.

## Sales recorded in land registers

87.0% of sales registered in August corresponded to urban properties and 13.0% to rustic properties. Among urban properties, 55.7% were housing sales.

In August, the number of merchandising of rustic properties decreased by 3.4% in the annual rate, while that of urban properties did so by 17.2%. Within the latter, housing sales recorded an annual decrease of 21.1%.



## Trend in monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation in the number of housing sales between the months of July and August in the last five years. In 2019, the monthly rate was -26.1%, the lowest for the period in question.

## Registered housing sales, by protection system and status

91.4% of dwellings transferred by sale in August were free dwellings and 8.6% were protected dwellings.

In annual terms, the number of transfers of free dwellings by merchanting decreased by 20.0%, and that of protected dwellings did so by 31.5%.

18.2% of dwellings transferred by sale in August were new, and 81.8% were used.

The number of transactions on new dwellings decreased 21.0%, while that of used dwellings decreased 21.1% compared with August 2018.



## Results by Autonomous Community

In August, the total number of property transfers recorded in the land registers per 100,000 inhabitants<sup>1</sup> reached its highest values in La Rioja (727), Castilla y León (550) and Aragón (538).

La Rioja (9.9%), Cantabria (9.7%) and Galicia (4.6%) registered the greatest annual variation rates.

In turn, Comunidad Foral de Navarra (-30.3%), Canarias (-18.8%) and Extremadura (-17.8%) registered the lowest annual rates.

As regards registered housing sales, the Autonomous Communities with the highest number of transfers per 100,000 inhabitants<sup>1</sup> were Comunitat Valenciana (136), Andalucía (110) and Illes Balears (109).



<sup>1</sup> This data have been calculated based on the provisional results of the population figures as at 01 January 2019. Only the population aged 18 to 84 years old is considered in these figures.

All Communities had annual negative growth rates in terms of the number of dwellings in August. The smallest increases were in Galicia (-8.6%), Castilla y León (-13.7%) and Cataluña (-14.9%).

In turn, Extremadura (-42.7%), Canarias (-41.2%) and Comunidad Foral de Navarra (-39.4%) registered the highest decreases.

## Revision and updating of data

Data for 2019 are provisional and will be reviewed when the data for the same period of the next year are published. In other words, when the data for August 2020 are published, the final data for the same month of 2019 will be disseminated.

## Methodological note

The Statistics on Transfer of Property Rights provide information on the number of rights on transfers of property during the reference month, on a national level, by province and Autonomous Community.

All information on transfers of property is taken from the information contained in the Land Registers for the whole country, by virtue of a partnership agreement signed in 2004 by both institutions.

**Type of survey:** continuous on a monthly basis

**Population scope:** registrations of transfers of property rights in the land registers

**Geographical scope:** the entire national territory, by Autonomous Community and provinces

**Reference period of the results:** the calendar month

**Reference period of the information:** the calendar month

**Classification:** sale, donation, inheritance, exchange and other property titles, of rustic and urban properties (dwellings, plots and other urban properties)

**Collection method:** administrative registers from Association of property and Mercantile registers of Spain
