Statistics on Transfer of Property Rights (STPR) August 2023. Provisional data


In August, 166,982 properties were entered in the property registers, 7.3% fewer than in the same month of the previous year

Registered housing sales decreased by 14.4% as compared with August 2022

The number of property transfers recorded in the land registers (from previously registered public deeds) in August was 166,982, that is, 7.3% fewer than in the same month in 2022.

As for registered property sales, the number of transfers was 93,917, with an 11.5% annual decrease.

¹The heading "Other titles" includes the following items: land consolidation, horizontal divisions, joint operations or mixtures of several transfer titles, transfers without title of acquisition, dation in payment, foreclosures and court orders.

Sales recorded in land registers

88.3% of registered sales in August were urban properties and 11.7% were rural properties. Among urban properties, 59.4% were housing sales.

In August, the number of rural property sales decreased by 1.8% in the annual rate, while there was a 12.6% decrease for urban properties. Within the latter, housing sales recorded an annual decrease of 14.4%.



Trend in monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation in the number of housing sales between the months of July and August over the last five years. In 2023, the monthly rate was 2.0%; that is, 4.6 points less than the previous year.

Registered housing sales, by social housing system and status

92.6% of housing transfers by sale in August were unrestricted housing, and 7.4% social housing.

In annual terms, the number of transfers of free dwellings by sale decreased by 14.5%, and that of protected dwellings did so by 13.9%.

19.1% of the dwellings transferred by sale in August were new, and 80.9% were used.

The number of new home transactions fell by 7.3% compared to August 2022 and that of used homes by 15.9%.



The number of housing sales between natural persons in August was 33,631, that is, 15.2% fewer than in the same month in 2022.

Results by Autonomous Community

In August, the total number of property transfers recorded in the land registries per 100,000 inhabitants¹ reached its highest values in Castilla y León (777), La Rioja (664) and Castilla-La Mancha (614).

Castilla y León (7.8%), Castilla-La Mancha (3.8%) and Principado de Asturias (2.8%) recorded the highest annual variation rates.

In contrast, Illes Balears (-28.2%), Comunidad de Madrid (-14.1%) and Andalucía (-13.8%), recorded the lowest annual rates.

With regard to registered housing sales, the Autonomous Communities with the highest number of transfers per 100,000 inhabitants¹ were Comunitat Valenciana (192), Andalucía, and Cantabria (both with 154).



¹ These data have been calculated based on the provisional results of the population figures as of 01 July 2023. Only the population aged 18 to 84 years old is considered in these figures.

The only autonomous communities in which the number of home sales increased in August were Comunidad Foral de Navarra (8.7%) and Principado de Asturias (3.7%).

In turn, Illes Balears (-37.7%), Canarias (-25.6%) and Comunidad de Madrid (-22.9%) recorded the highest decreases.

Revision and updating of data

The data for 2023 are provisional and will be reviewed when the data for the same period next year are published. In other words, when the data for August 2024 are published, the final data for the same month in 2023 will be disseminated.

Methodological note

The Statistics on Transfer of Property Rights provide information on the number of rights on transfers of property during the reference month, nationally, by province and Autonomous Community.

All information on transfers of property is taken from the information contained in the Land Registers for the whole country, on the basis of a partnership agreement signed in 2004 by both institutions.

Type of survey: continuous on a monthly basis

Geographical scope: the entire national territory, by Autonomous Community and provinces

Reference period of the results: the calendar month

Reference period of the information: the calendar month

Classification: sale, donation, inheritance, exchange and other property titles, of rural and urban properties (dwellings, plots and other urban properties)

Collection method: administrative registers from Association of Land and Mercantile Registers of Spain
