

Statistics on Transfer of Property Rights (STPR)
September 2016. *Provisional data*


In September, the number of property transfers registered is 132,263 properties, that is, 0.5% less than in the same month of the previous year

The merchanting of registered dwellings increases by 13.2%, as compared with September of 2015

The number of property transfers **recorded in the land registries (from public deeds previously registered)** was 132,263 in September, that is, 0.5% less than in the same month of 2015.

Regarding the merchanting of registered properties, the number of transfers was 69,093, with a 8.7% annual increase.

¹ "Other titles" includes land consolidation, horizontal divisions, joint ventures or mixtures of several titles transmission, transmissions without title of acquisition, non recourse debt, foreclosures and court awards.

Merchanting recorded in the land registries

86.4% of the registered merchanting in September corresponded to urban properties and 13.6% to rustic properties. Among the urban properties, 58.5% were merchanting of dwellings.

In September, the number of merchanting of rustic properties decreased by 11.4% in the annual rate while that of urban properties increased 12.7%. Within the latter, merchanting of dwellings recorded an annual increase of 13.2%.



Evolution of the monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation in the number of merchanting of dwellings between the months of August and September of the last five years. In 2016, the monthly rate was -1.6%, that is, 6.2 points less than that of the previous year.

Registered merchanting on dwellings, by protection system and status

88.7% of transfers of dwellings by merchanting in September were free housing, and 11.3% were protected housing.

In annual terms, the number of transfers of free dwellings by merchanting increased by 11.4%, and that of protected dwellings increased by 29.5%.


17.3% of the dwellings transferred by merchanting in September were new, and 82.7% were used.

The number of transactions on new dwellings decreased by 0.6% as compared to September 2015 and, the number of used dwellings increased by 16.5%.

Results by Autonomous Community

In September 2016, the total number of property transfers recorded in the land registries per 100,000 inhabitants¹ reached its highest value in Comunidad Foral de Navarra (540), Castilla y León (526) and Aragón (481).

Comunidad Foral de Navarra (18.4%), Comunidad de Madrid (17.2%) and Cataluña (6.9%) registered the greatest annual variations.

In turn, the Autonomous Communities that registered the lowest annual rates were La Rioja (-23.0%), Aragón (-17.2%) and Castilla-La Mancha (-11.9%).


Regarding the merchanting on registered dwellings, the Autonomous Communities with the highest number of transfers per 100,000 inhabitants¹ were Comunitat Valenciana (133), Illes Balears (125) and Comunidad de Madrid (109).

¹ This data was calculated from the provisional data of the Population Figures on 1 January 2016. Only the population aged 18 to 84 years old was considered.

The Autonomous Communities showing the greatest annual variation rate in the merchanting of dwellings in September were Comunidad de Madrid (29.3%), Cataluña (25.8%) and Cantabria (24.5%).

In turn, Región de Murcia (-15.9%), La Rioja (-6.2%) and País Vasco (-2.2%) registered the lowest annual rates in August.
