
Statistics on Transfer of Property Rights (STPR)
September 2019. Provisional data

In September, the number of property transfers registered was 143,471 properties, that is, 3.7% less than in the same month of the previous year

Registered housing sales decreased by 12.0%, as compared with September 2018

The number of property transfers recorded in the land registries (from public deeds previously registered) was 143,471 in September, that is, 3.7% less than in the same month of 2018.

Regarding registered property sales, the number of transfers was 74,741, with a 11.9% annual decrease.

¹The heading "Other titles" includes the following items: land consolidation, horizontal divisions, joint operations or mixtures of several transfer titles, transfers without title of acquisition, dation in payment, foreclosures and court orders.

Sales recorded in land registers

86.7% of sales registered in September corresponded to urban properties and 13.3% to rustic properties. Among urban properties, 58.6% were housing sales.

In September, the number of merchanting of rustic properties decreased by 1.0% in the annual rate, while that of urban properties did so by 13.4%. Within the latter, housing sales recorded an annual decrease of 12.0%.



Trend in monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation in the number of housing sales between August and September in the last five years. In 2019, the monthly rate was 7.4%, the highest for the period in question.

Registered housing sales, by protection system and status

90.8% of dwellings transferred by sale in September were free dwellings, and 9.2% were protected dwellings.

In annual terms, the number of transfers of free dwellings by merchanting decreased by 11.4%, and that of protected dwellings did so by 17.1%.

16.9% of the dwellings transferred by sale in September were new, and 83.1% were used.

The number of transactions on new dwellings decreased 20.1%, while that of used dwellings decreased 10.1% as compared with September 2018.



Results by Autonomous Community

In September, the total number of property transfers recorded in the land registries per 100,000 inhabitants¹ reached its highest values in Aragón (584), Castilla y León (575) and La Rioja (574).

Aragón (16.6%), Galicia (5.4%) and Cataluña (3.9%) registered the highest annual variation rates.

Meanwhile, Principado de Asturias (-14.5%), Comunidad de Madrid (-12.9%) and La Rioja (-11.5%), registered the lowest annual rates.

Regarding registered housing sales, the Autonomous Communities with the highest number of transfers per 100,000 inhabitants¹ were Comunitat Valenciana (151), Región de Murcia (135) and Comunidad de Madrid and Illes Balears (both 111).



¹ This data have been calculated based on the provisional results of the population figures as at 01 January 2019. Only the population aged 18 to 84 years old is considered in these figures.

The only Autonomous Communities that registered annual increases in the number of housing sales in September were Aragón (3.7%) and Región de Murcia (3.1%).

Meanwhile, Principado de Asturias (-27.5%), La Rioja (-25.2%) and Comunidad Foral de Navarra (-22.6%) registered the highest decreases.

Revision and updating of data

The data for 2019 are provisional and will be reviewed in the third quarter of next year.

Methodological note

The Statistics on Transfer of Property Rights provide information on the number of rights on transfers of property during the reference month, on a national level, by province and Autonomous Community.

All information on transfers of property is taken from the information contained in the Land Registers for the whole country, by virtue of a partnership agreement signed in 2004 by both institutions.

Type of survey: continuous on a monthly basis

Population scope: registrations of transfers of property rights in the land registers

Geographical scope: the entire national territory, by Autonomous Community and provinces

Reference period of the results: the calendar month

Reference period of the information: the calendar month

Classification: sale, donation, inheritance, exchange and other property titles, of rustic and urban properties (dwellings, plots and other urban properties)

Collection method: administrative registers from Association of property and Mercantile registers of Spain
