

Statistics on Transfer of Property Rights (STPR) October 2020. Provisional data

**In October, 156,875 properties were registered in the land registers,
8.2% less than in the same month of the previous year**


**Registered home sales decreased by 13.3% compared to October
2019 and increased by 0.6% compared to the previous month**

The number of property transfers recorded in the land registers (from previously registered public deeds) was 156,875 in October; that is, 8.2% more than in the same month of 2019.

Regarding registered property sales, the number of transfers was 77,536, with a 11.6% annual decrease.

¹The heading "Other titles" includes the following items: land consolidation, horizontal divisions, joint operations or mixtures of several transfer titles, transfers without title of acquisition, dation in payment, foreclosures and court orders.

Sales recorded in land registers

84.2% of registered sales in October corresponded to urban properties and 15.8% to rustic properties. Among urban properties, 57.6% were housing sales.

In October, the number of rustic property sales increased by 1.6% in the annual rate while that of urban properties decreased by 13.7%. Within the latter, housing sales recorded an annual decrease of 13.3%.



Trend in monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation in the number of housing sales between the months of September and October in the last five years. The monthly rate in 2020 was -0.6%, or 13.9 points less than that of the previous year.

Registered housing sales, by protection system and status

91.3% of dwellings transferred by sale in October were free dwellings and 8.7% were protected dwellings.

In annual terms, the number of transfers of free dwellings by merchanting decreased by 12.9%, and that of protected dwellings did so by 17.0%.

20.5% of the dwellings transferred by sale in October were new, and 79.5% were used.

The number of transactions on new dwellings decreased 5.0%, while that of used dwellings decreased 15.2% as compared with October 2019.



Results by Autonomous Community

In October the total number of property transfers recorded in the land registries per 100,000 inhabitants¹ reached its highest values in La Rioja (717), Castilla y León (715) and Principado de Asturias (613).

Extremadura (7.3%), Castilla y León (2.1%) and Aragón (1.8%) recorded the highest annual variation rates.

In turn, Comunidad Foral de Navarra (-31.1%), Canarias (-22.0%) and Illes Balears (-18.2%) registered the lowest annual rates.

With regard to registered housing sales, the Autonomous Communities with the highest number of transfers per 100,000 inhabitants¹ were Comunitat Valenciana (135), Andalucía and Región de Murcia (both with 120).



¹ This data have been calculated based on the provisional results of the population figures as at 01 January 2020. Only the population aged 18 to 84 years old is considered in these figures.

The Autonomous Communities that registered the greatest annual increases in the number of housing sales in October were Extremadura (31.0%), Principado de Asturias (21.6%) and Castilla y León (1.4%).

On the other hand, Illes Balears (-28.7%), Canarias (-24.4%) and La Rioja (-23.7%) registered the greatest decreases.

Revision and updating of data

Data for 2020 is provisional and will be reviewed when the data for the same period of the next year is published. In other words, when the data for October 2021 is published, the final data for the same month of 2020 will be disseminated.

Methodological note

The Statistics on Transfer of Property Rights provide information on the number of rights on transfers of property during the reference month, on a national level, by province and Autonomous Community.

All information on transfers of property is taken from the information contained in the Land Registers for the whole country, by virtue of a partnership agreement signed in 2004 by both institutions.

Type of survey: continuous on a monthly basis

Population scope: registrations of transfers of property rights in the land registers

Geographical scope: the entire national territory, by Autonomous Community and provinces

Reference period for the results: the calendar month

Reference period for the information: the calendar month

Classification: sale, donation, inheritance, exchange and other property titles, of rustic and urban properties (dwellings, plots and other urban properties)

Collection method: administrative registers from Association of property and Mercantile registers of Spain
