

Statistics on Transfer of Property Rights (STPR) November 2018. Provisional data

**In November, 170,271 properties are registered in the land registers,
9.4% more than in the same month of the previous year**


**Registered housing sales increased by 2.8%, as compared with
November 2017**

The number of property transfers recorded in the land registers (from public deeds previously registered) was 170,271 in November, that is, 9.4% more than in the same month of 2017.

Regarding registered property sales, the number of transfers was 85,348, with an annual increase of 4.0%.

¹The heading "Other titles" includes the following items: land consolidation, horizontal divisions, joint operations or mixtures of several transfer titles, transfers without title of acquisition, dation in payment, foreclosures and court orders.

Sales recorded in land registers

86.5% of sales registered in November corresponded to urban properties and 13.5% to rustic properties. Among urban properties, 57.1% were housing sales.

In November, the number of sales of rustic properties decreased by 3.7% in the annual rate while that of urban properties increased 5.3%. Within the latter, housing sales recorded an annual increase of 2.8%.



Trend in monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation in the number of housing sales between the months of October and November in the last five years. In 2018, the monthly rate was -3.2%, that is, 12.3 points less than that of the previous year.

Registered housing sales, by protection system and status

90.4% of dwellings transferred by sale in November were free-market dwellings and 9.6% were protected dwellings.

In annual terms, the number of transfers of free-market dwellings by sale increased by 1.9%, and that of protected dwellings did so by 11.3%.

19.1% of dwellings transferred by sale in November were new, and 80.9% were used.


The number of transactions on new dwellings increased by 7.9%, while that of used dwellings increased 1.6% as compared with November 2017.

Results by Autonomous Community

In November, the total number of property transfers recorded in the land registries per 100,000 inhabitants¹ reached its highest values in La Rioja (723), Castilla y León (718) and Comunitat Valenciana (610).

Comunidad de Madrid (21.7%), Cantabria (19.6%) and La Rioja (19.4%) registered the highest annual variation rates.

In turn, Aragón (-11.7%), Illes Balears (-6.0%) and Extremadura (-4.4%) registered the lowest annual rates.

Considering registered housing sales, the Autonomous Communities with the highest number of transfers per 100,000 inhabitants¹ were Comunitat Valenciana (168), La Rioja (144) Cantabria (128).



¹ This data have been calculated based on the provisional results of the population figures as at 01 July 2018. Only the population aged 18 to 84 years old is considered in these figures.

The Autonomous Communities that registered the greatest annual increases in the number of housing sales in November were Cantabria (30.3%), La Rioja (28.8%) and Castilla-La Mancha (26.6%).

In turn, Illes Balears (-7.2%), Andalucía (-5.9%) and Extremadura (-5.0%) registered the lowest annual variation rates in November.

Revision and updating of data

The data published today are provisional and will be reviewed in September of this year.

Methodological note

The Statistics on Transfer of Property Rights provide information on the number of rights on transfers of property during the reference month, on a national level, by province and Autonomous Community.

All information on transfers of property is taken from the information contained in the Land Registers for the whole country, by virtue of a partnership agreement signed in 2004 by both institutions.

Type of survey: continuous on a monthly basis

Population scope: registrations of transfers of property rights in the land registers

Geographical scope: the entire national territory, by Autonomous Community and provinces

Reference period of the results: the calendar month

Reference period of the information: the calendar month

Classification: sale, donation, inheritance, exchange and other property titles, of rustic and urban properties (dwellings, plots and other urban properties)

Collection method: administrative registers from Association of property and Mercantile registers of Spain
