

Statistics on Transfer of Property Rights (STPR) November 2020. Provisional data

**In November, 163,536 properties are registered in the land registers,
6.2% more than in the same month of the previous year**


**Registered home sales increased 1.9% in the annual rate and by
5.4% in the monthly rate**

The number of property transfers recorded in the land registers (from public deeds previously registered) was 163,536 in November, that is, 6.2% more than in the same month of 2019.

Regarding registered property sales, the number of transfers was 83,221, with an annual increase of 4.2%.

¹The heading "Other titles" includes the following items: land consolidation, horizontal divisions, joint operations or mixtures of several transfer titles, transfers without title of acquisition, dation in payment, foreclosures and court orders.

Sales recorded in land registers

84.6% of sales registered in November corresponded to urban properties and 15.4% to rustic properties. Among urban properties, 56.3% were housing sales.

In November, the number of rustic properties sales increased by 17.8% in the annual rate, while that of urban properties did so by 2.0%. Within the latter, housing sales recorded an annual increase of 1.9%.



Trend in monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation in the number of housing sales between the months of October and November in the last five years. In 2020, the monthly rate was 5.4%, that is, 15.6 points more than the previous year.

Registered housing sales, by protection system and status

91.7% of dwellings transferred by sale in November were free-market dwellings and 8.3% were protected dwellings.

In annual terms, the number of transfers of free dwellings by merchanting increased by 2.4%, and that of protected dwellings decreased by 3.0%.

19.5% of dwellings transferred by sale in November were new, and 80.5% were used.

The number of transactions on new dwellings increased by 0.6%, and that of used dwellings by 2.2% as compared with November 2019.



Results by Autonomous Community

In November, the total number of property transfers recorded in the land registries per 100,000 inhabitants¹ was highest in La Rioja (788), Castilla y León (708) and Castilla-La Mancha (651).

País Vasco (20.3%), Extremadura (17.2%) and Galicia (15.1%) registered the highest annual variation rates.

In turn, Región de Murcia (-6.5%), Canarias (-5.4%) and Comunidad Foral de Navarra (-4.1%) showed the lowest annual rates.

As regards registered housing sales, the Autonomous Communities with the highest number of transfers per 100,000 inhabitants¹ were Comunitat Valenciana (147), Castilla-la Mancha (129) and La Rioja (120).


¹ This data have been calculated based on the provisional results of the population figures as at 01 January 2020. Only the population aged 18 to 84 years old is considered in these figures.

The Autonomous Communities that registered the greatest annual increases in the number of merchanting of dwellings in November were Castilla-La Mancha (33.5%), Principado de Asturias (31.4%) and Extremadura (24.9%).

In turn, IllesBalears (-16.8%), Andalucía (-7.1%) Región de Murcia Comunidad Foral de Navarra (both with -6.0%) registered the largest decreases.

Revision and updating of data

Data for 2020 is provisional and will be reviewed when the data for the same period of the next year is published. In other words, when the data for November 2021 is published, the final data for the same month of 2020 will be disseminated.

Methodological note

The Statistics on Transfer of Property Rights provide information on the number of rights on transfers of property during the reference month, on a national level, by province and Autonomous Community.

All information on transfers of property is taken from the information contained in the Land Registers for the whole country, by virtue of a partnership agreement signed in 2004 by both institutions.

Type of survey: continuous on a monthly basis

Population scope: registrations of transfers of property rights in the land registers

Geographical scope: the entire national territory, by Autonomous Community and provinces

Reference period for the results: the calendar month

Reference period for the information: the calendar month

Classification: sale, donation, inheritance, exchange and other property titles, of rustic and urban properties (dwellings, plots and other urban properties)

Collection method: administrative registers from Association of property and Mercantile registers of Spain
