In December, 134,523 properties were registered in the land registers, 6.0% more than in the same month of the previous year

Registered housing sales increased by 3.8%, as compared with December 2017


In 2018 housing sales increased by 10.1%

The number of property transfers recorded in the land registers (from public deeds previously registered) was 134,523 in December, that is, 6.0% more than in the same month of 2017.

Regarding registered property sales, the number of transfers was 69,524, with an annual increase of 7.2%.

Sales recorded in land registers

In December, 85.2% of registered sales corresponded to urban properties and 14.8% to rustic properties. Among urban properties, 57.1% were housing sales.

In December, the number of rustic property sales increased by 6.4% in the annual rate, while that of urban properties did so by 7.4%. Within the latter, housing sales recorded an annual increase of 3.8%.



Trend in monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation in the number of housing sales between the months of November and December in the last five years. In 2018, the monthly rate was -19.7%, that is, 0.8 points more than the previous year.

Registered housing sales, by protection system and status

In December, 90.1% of dwellings transferred by sale in were free-market dwellings and 9.9% were protected dwellings.

In annual terms, the number of free dwellings transferred by sale increased by 4.0%, and that of protected dwellings by 1.7%.

18.2% of dwellings transferred by sale in December were new, and 81.8% were used.


The number of transactions on new dwellings increased by 6.5%, while that of used dwellings increased by 3.2% as compared with December 2017.

Results by Autonomous Community

In December, the total number of property transfers recorded in the land registries per 100,000 inhabitants¹ was highest in La Rioja (568), Castilla y León (549) and Castilla-La Mancha (502).

Cataluña and Región de Murcia (both with 15.3%) and Andalucía (13.3%) registered the highest annual variation rates.

In turn, Illes Balears (-13.2%), Comunidad Foral de Navarra (-8.4%) and Aragón (-4.8%), registered the lowest annual rates.

As regards registered housing sales, the Autonomous Communities with the highest number of transfers per 100,000 inhabitants¹ were Comunitat Valenciana (131), Illes Balears (109) and Cantabria (108).



The Autonomous Communities that registered the greatest annual increases in the number of housing sales in December were Región de Murcia (22.6%), Cantabria (19.0%) and La Rioja (18.6%).

In turn, Canarias (-14.8%), Comunidad Foral de Navarra (-10.8%) and Principado de Asturias (-8.4%) registered the lowest annual variation rates in December.

December 2018. Percentage**




Results for the whole of the year 2018

During 2018, 1,967,109 property transfers were recorded in the land registers, 9.2% more than in 2017.

Regarding registered property sales, the number of transfers was 1,025,039, with an increase of 9.2%.

Sales recorded in land registers

In 2018, 86.4% of registered sales corresponded to urban properties and 13.6% to rustic properties. Among the urban properties, 58.1% were housing sales.

Rustic property sales increased by 3.9% and urban property sales by 10.1%. Within the latter, housing sales increased by 10.1%.

Registered housing sales, by protection system and status

In 2018, 90.3% of dwellings transferred by sale were free-market dwellings and 9.7% were protected dwellings.

The number of transfers of free-market dwellings by sale increased by 10.1% as compared with 2017 and that of protected dwellings did so by 10.3%.



In 2018, 18.0% of the dwellings transferred by sale were new and 82.0% were used.

The number of transactions on new dwellings increased 11.1%, while that of used dwellings did so by 9.9% as compared with 2017.

Results by Autonomous Community

The total number of properties transferred per 100,000 inhabitants¹ reached the highest levels in 2018 in La Rioja (8,616), Castilla y León (7,798) and Aragón (7,348).

Región de Murcia (18.9%), Andalucía (15.6%) and Comunitat Valenciana (13.5%) registered the highest annual variation rates in 2018. In turn, Comunidad Foral de Navarra (-1.7%), Aragón (1.8%) and Illes Balears (2.2%) registered the lowest annual rates.



In terms of registered housing sales, the Autonomous Communities with the highest number of transfers per 100,000 inhabitants¹ in 2018 were Comunitat Valenciana (2,010), Illes Balears (1,641) and Andalucía (1,537).

The Autonomous Communities that registered the greatest annual increases in the number of housing sales in 2018 were Región de Murcia (24.3%), La Rioja (18.9%) and Castilla-La Mancha (18.1%). In turn, Illes Balears (-2.9%), Cataluña and Canarias (both with 4.0%) registered the lowest annual variation rates.

Revision and updating of data

The data published today are provisional and will be reviewed in September of this year.

Methodological note

The Statistics on Transfer of Property Rights provide information on the number of rights on transfers of property during the reference month, on a national level, by province and Autonomous Community.

All information on transfers of property is taken from the information contained in the Land Registers for the whole country, by virtue of a partnership agreement signed in 2004 by both institutions.

Type of survey: continuous on a monthly basis

Population scope: registrations of transfers of property rights in the land registers

Geographical scope: the entire national territory, by Autonomous Community and provinces

Reference period of the results: the calendar month

Reference period of the information: the calendar month

Classification: sale, donation, inheritance, exchange and other property titles, of rustic and urban properties (dwellings, plots and other urban properties)

Collection method: administrative registers from Association of property and Mercantile registers of Spain
