Statistics on Transfer of Property Rights (STPR)

December 2019 and year 2019. Provisional data

In December, 137,435 properties were registered in the land registers, 1.2% more than in the same month of the previous year

Registered housing sales increased by 1.8%, as compared with December 2018


In 2019, housing sales decreased by 3.3%

The number of property transfers recorded in the land registers (from public deeds previously registered) was 137,435 in December, that is, 1.2% more than in the same month of 2018.

Regarding registered property sales, the number of transfers was 71,179, with an annual increase of 1.5%.

Sales recorded in land registers

In December, 85.9% of registered sales corresponded to urban properties and 14.1% to rustic properties. Among urban properties, 56.9% were housing sales.

In December, the number of rustic property sales dropped by 2.8% in the annual rate while that of urban properties increased 2.3%. Within the latter, housing sales recorded an increase of 1.8%.



In order to contribute to the analysis and interpretation of the data, the following chart shows the variation in the number of housing sales between the months of November and December in the last five years. In 2019, the monthly rate was -10.1%.

Registered housing sales, by protection system and status

In December, 90.9% of dwellings transferred by sale in were free-market dwellings and 9.1% were protected dwellings.

In annual terms, the number of transfers of free dwellings by merchandising increased by 2.6%, and that of protected dwellings decreased by 5.3%.

18.9% of dwellings transferred by sale in December were new, and 81.1% were used.

The number of transactions on new dwellings increased by 6.8%, and that of used dwellings by 0.7% as compared with December 2018.



Results by Autonomous Community

In December, the total number of property transfers recorded in the land registries per 100,000 inhabitants¹ was highest in La Rioja (610), Castilla y León (559) and Castilla-La Mancha (534).

Illes Balears (14.5%), Cantabria (12.8%) and La Rioja (7.9%) registered the highest annual variation rates.

In turn, Comunidad Foral de Navarra (-10.0%), Comunidad de Madrid (-6.9%) and Galicia (-4.3%) presented the lowest annual rates.

With regard to registered housing sales, the Autonomous Communities with the highest number of transfers per 100,000 inhabitants¹ were Comunitat Valenciana (133), Andalucía and Aragón (both with 107).



The Autonomous Communities that registered the greatest annual increases in the number of housing sales in December were Castilla-La Mancha (18.3%), Comunidad Foral de Navarra (18.0%) and Aragón (13%).

In turn, Canarias (-14.2%), Castilla y León (-6.7%) and Región de Murcia (-3.9%) registered the greatest decreases.

Annual variation in the number of housing sales by Autonomous Community December 2019. Percentage




Results for the whole of year 2019

During 2019, 2,036,320 property transfers were recorded in the land registers, 2.7% more than in 2018.

Sales recorded in land registers

In 2019, 86.3% of registered sales corresponded to urban properties and 13.7% to rustic properties. Among the urban properties, 57.3% were housing sales.

Rustic property sales decreased by 0.5% and urban property sales by 1.9%. Within the latter, housing sales decreased by 3.3%.

Registered housing sales, by protection system and status

In 2019, 90.5% of dwellings transferred by sale were free-market dwellings and 9.5% were protected dwellings. The number of transfers of free-market dwellings by sale decreased by 3.1% as compared with 2018 and that of protected dwellings did so by 4.9%.



In 2019, 18.5% of the dwellings transferred by sale were new and 81.5% were used. The number of transactions on new dwellings increased 1.2%, while that of used dwellings decreased by 4.2% as compared with 2018.

Results by Autonomous Community

The total number of properties transferred per 100,000 inhabitants¹ reached the highest levels in the whole 2019 in La Rioja (9,558), Castilla y León (7,998) and Castilla-La Mancha (7,796).

La Rioja (11.6%), Castilla-La Mancha (9.4%) and Cataluña (8.5%) registered the highest variation rates in 2019. In turn, Comunidad Foral de Navarra (-12.1%), Illes Balears (-5.5%) and Comunidad de Madrid (-4.2%) showed the lowest decreases.



In terms of registered housing sales, the Autonomous Communities with the highest number of transfers per 100,000 inhabitants¹ in the year 2019 were Comunitat Valenciana (1,890), Andalucía (1,511) and La Rioja (1,503).

The Autonomous Communities that registered the greatest annual increases in the number of housing sales in 2019 were Castilla-La Mancha (7.5%), Extremadura (5.7%) and La Rioja (3.1%). In turn, Canarias (-14.0%), Illes Balears (-10.9%) and Comunidad Foral de Navarra (-9.7%) registered the highest decreases.

Revision and updating of data

The 2019 data is provisional and will be reviewed in this year's third quarter.

Methodological note

The Statistics on Transfer of Property Rights provide information on the number of rights on transfers of property during the reference month, on a national level, by province and Autonomous Community.

All information on transfers of property is taken from the information contained in the Land Registers for the whole country, by virtue of a partnership agreement signed in 2004 by both institutions.

Type of survey: continuous on a monthly basis

Population scope: registrations of transfers of property rights in the land registers

Geographical scope: the entire national territory, by Autonomous Community and provinces

Reference period for the results: the calendar month

Reference period for the information: the calendar month

Classification: sale, donation, inheritance, exchange and other property titles, of rustic and urban properties (dwellings, plots and other urban properties)

Collection method: administrative registers from Association of property and Mercantile registers of Spain
