
In 2020, housing sales decreased by 17.7%

The number of property transfers recorded in the land registers (from public deeds previously registered) was 150,891 in December, that is, 9.1% more than in the same month of 2019.

Regarding registered property sales, the number of transfers was 76,516, with an annual increase of 7.2%.

Sales recorded in land registers

In December, 84.3% of registered sales corresponded to urban properties and 15.7% to rustic properties. Among urban properties, 56.0% were housing sales.

In December, the number of rustic property sales increased by 18.5% in the annual rate, while that of urban properties did so by 5.3%. Within the latter, housing sales recorded an annual increase of 3.7%.



Trend in monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation in the number of housing sales between the months of November and December in the last five years. In 2020, the monthly rate was -8.9%, that is, 1.6 points more than the previous year.

Registered housing sales, by protection system and status

In December, 91.6% of dwellings transferred by sale in were free-market dwellings and 8.4% were protected dwellings.

In annual terms, the number of transfers of free dwellings by merchanting increased by 4.5%, and that of protected dwellings decreased by 4.4%.

20.5% of dwellings transferred by sale in December were new, and 79.5% were used.

The number of transactions on new dwellings increased by 12.6%, and that of used dwellings by 1.6% as compared with December 2019.



Results by Autonomous Community

In December, the total number of property transfers recorded in the land registers per 100,000 inhabitants¹ reached its highest values in La Rioja (679), Castilla y León (627) and Aragón (586).

Galicia (33.3%), Extremadura (32.0%) and Cantabria (23.0%) registered the highest annual variation rates.

In turn, Canarias (-17.6%), Illes Balears (-13.6%) and Región de Murcia (0.9%) registered the lowest annual rates.

Considering registered housing sales, the Autonomous Communities with the highest number of transfers per 100,000 inhabitants¹ were Comunitat Valenciana (132), La Rioja (120) Cantabria (119).



The Autonomous Communities that registered the greatest annual increases in the number of housing sales in December were La Rioja (37.2%), Galicia (28.8%) and Cantabria (28.3%).

In turn, Illes Balears (-20.0%), Canarias (-16.5%) and Comunidad Foral de Navarra (-7.6%) registered the highest decreases.

December 2020. Percentage




Results for the whole of year 2020

During 2020, 1,692,446 property transfers were recorded in the land registers, 17.9% less than in 2019.

Regarding registered property sales, the number of transfers was 849,670, with a decrease of 17.1%.

Sales recorded in land registers

In 2020, 85.6% of registered sales corresponded to urban properties and 14.4% to rustic properties. Among the urban properties, 57.2% were housing sales.

Rustic property sales decreased by 13.1% and urban property sales by 17.8%. Within the latter, housing sales decreased by 17.7%.

Registered housing sales, by protection system and status

In 2020, 91.0% of dwellings transferred by sale were free-market dwellings and 9.0% were protected dwellings. The number of transfers of free-market dwellings by sale decreased by 17.3% as compared with 2019 and that of protected dwellings did so by 22.4%.



In 2020, 19.9% of the dwellings transferred by sale were new and 80.1% were used. The number of new home transactions fell 11.2% compared to 2019 and that of used homes decreased by 19.2%.

The special situation in 2020 due to the health crisis caused by COVID-19 caused the evolution of home sales to be different in the different periods of the year.


During the months in which the state of alarm was enacted for the management of the health crisis situation, attention to the public in the Property Registries was carried out exclusively by email or by telephone, in accordance with the Resolution of the Office of Legal Security and Public Trust of March 15, 2020.

Over the course of these months, during which the opening of the Property Registries to the public was suspended, there was a significant decrease in home sales, with the lowest rate in the month of May 2020 (-53.7 %).

With the de-escalation and the arrival of the “new normality,” there was a progressive recovery in the number of registered home sales.

Results by Autonomous Community

The total number of properties transferred per 100,000 inhabitants¹ reached the highest levels in the whole 2020 in La Rioja (7,547), Castilla y León (7,156) and Castilla-La Mancha (6,309).

All the autonomous communities registered decreases in the number of transferred farms. Galicia (-7.3%), Principado de Asturias (-8.4%) and Cantabria (-10.8%) had the least negative rates. In turn, the greatest decreases were registered in Comunidad Foral de Navarra (-29.6%), Canarias-28.6%) and Cataluña (-23.8%).



In terms of registered housing sales, the Autonomous Communities with the highest number of transfers per 100,000 inhabitants¹ in the year 2020 were Comunitat Valenciana (1,469), La Rioja (1,306) and Región de Murcia (1,258).

The Autonomous Communities that registered the lowest annual decreases in the number of housing sales in 2020 were Extremadura (-6.5%), Principado de Asturias (-9.0%) and Cantabria (-10.7%). On the other hand, Illes Balears (-23.2%), Comunitat Valenciana (-22.1%) and Canarias (-21.9%) presented the greatest decreases.

Revision and updating of data

The 2020 data is provisional and will be reviewed in this year's third quarter.

Methodological note

The Statistics on Transfer of Property Rights provide information on the number of rights on transfers of property during the reference month, on a national level, by province and Autonomous Community.

All information on transfers of property is taken from the information contained in the Land Registers for the whole country, by virtue of a partnership agreement signed in 2004 by both institutions.

Type of survey: continuous on a monthly basis

Population scope: registrations of transfers of property rights in the land registers

Geographical scope: the entire national territory, by Autonomous Community and provinces

Reference period for the results: the calendar month

Reference period for the information: the calendar month

Classification: sale, donation, inheritance, exchange and other property titles, of rustic and urban properties (dwellings, plots and other urban properties)

Collection method: administrative registers from Association of property and Mercantile registers of Spain
