

Statistics on Transfer of Property Rights (STPR) December 2022 and year 2022. Provisional data

In December, the number of property transfers registered is 153,937 properties, that is, 14.2% less than in the same month of the previous year

Registered housing sales decreased by 10.2%, as compared with December 2021


In 2022, housing sales increased by 14.7%

The number of property transfers recorded in the land registers (from previous public deeds) in December was 153,937, that is, 14.2% less than in the same month of 2021.

As for registered property sales, the number of transfers was 83,861, with a 13.4% annual decrease.

Sales recorded in land registers

In December, 86.6% of registered sales corresponded to urban properties and 13.4% to rustic properties. Among urban properties, 59.7% were housing sales.

In December, the number of rustic property sales decreased by 15.1% in the annual rate, while there was a 13.1% decrease for urban properties. Within the latter, housing sales recorded an annual decrease of 10.2%.



Trend in monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation in the number of housing sales between the months of November and December in the last five years. The monthly rate in 2022 was -21.3%, or 18.3 points less than that of the previous year.

Registered housing sales, by protection system and status

In December, 92.3% of dwellings transferred by sale in were free-market dwellings and 7.7% were protected dwellings.

In annual terms, the number of transfers of free dwellings by merchanting decreased by 9.8%, and that of protected dwellings did so by 14.7%.

17.9% of dwellings transferred by sale in December were new, and 82.1% were used.

The number of new home transactions declined 18.8% compared to December 2021 and that of used homes 8.1%.



Results by Autonomous Community

In December, the total number of property transfers recorded in the land registries per 100,000 inhabitants¹ reached its highest values in Castilla y León (673), La Rioja (595) and Aragón (590).

All the Autonomous Communities presented negative annual variation rates. Castilla-La Mancha (-23.2%), Comunidad de Madrid (-21.7%) and Comunidad Foral de Navarra (-21.2%) showed the largest decreases. In turn, Aragón (-2.3%), Comunitat Valenciana (-5.4%) and Castilla y León (-6.5%) registered the smallest decreases.

With regard to registered housing sales, the Autonomous Communities with the highest number of transfers per 100,000 inhabitants¹ were Comunitat Valenciana (171), Cantabria (142) and Andalucía (136).



The only autonomous community in which the number of house sales increased in December was Principado de Asturias (5.1%). The smallest decreases were in Comunidad Foral de Navarra (-0.2%) and Región de Murcia (-0.5%).

In turn, La Rioja (-19.5%), Comunidad de Madrid (-16.9%) and Andalucía (-14.1%) registered the lowest decreases.

December 2022. Percentage




Results for the whole of year 2022

During 2022, 2,237,885 property transfers were recorded in the land registers, 3.3% more than in 2021.

Sales recorded in land registers

In 2022, 87.4% of registered sales corresponded to urban properties and 12.6% to rustic properties. Among the urban properties, 59.6% were housing sales.

Purchases and sales of rustic properties decreased by 2.2%, while those of urban properties increased by 10.3%. Within the latter, housing sales increased by 14.7%.

Registered housing sales, by protection system and status

In 2022, 92.2% of dwellings transferred by sale were free-market dwellings and 7.8% were protected dwellings. The number of transfers of free-market dwellings by sale increased by 15.6% as compared with 2021 and that of protected dwellings did so by 4.8%.



In 2022, 18.0% of the dwellings transferred by sale were new and 82.0% were used. The number of new home transactions rose by 2.6% compared to 2021 and that of used homes by 17.7%.

Results by Autonomous Community

The total number of properties transferred per 100,000 inhabitants¹ reached the highest levels in the whole of 2022 in La Rioja (9,530), Castilla y León (9,348) and Aragón (8,568).

Canarias (15.7%), Comunitat Valenciana (9.1%) and Aragón (8.1%) registered the highest variation rates. In turn, Comunidad Foral de Navarra (-17.1%), Comunidad de Madrid (-3.7%) and Cantabria (-0.3%) showed the only decreases.



In terms of registered housing sales, the Autonomous Communities with the highest number of transfers per 100,000 inhabitants¹ in the year 2022 were Comunitat Valenciana (2,442), La Rioja (2,014) and Andalucía (2,010).

The Autonomous Communities that registered the greatest annual increases in the number of housing sales in 2022 were Canarias (31.6%), Illes Balears (25.6%) and Comunitat Valenciana (23.9%).

The only autonomous community with a negative annual variation rate was Comunidad Foral de Navarra (-0.5%).

Revision and updating of data

The 2022 data is provisional and will be reviewed in this year's third quarter.

Methodological note

The Statistics on Transfer of Property Rights provide information on the number of rights on transfers of property during the reference month, on a national level, by province and Autonomous Community.

All information on transfers of property is taken from the information contained in the Land Registers for the whole country, by virtue of a partnership agreement signed in 2004 by both institutions.
