#### Services Sector Activity Indicators. Base 2005 February 2010. Provisional data

#### Main results

– The interannual rate of the **Services Sector Turnover General Index** is **–0.9%**, more than three points above that registered in January.

- The **average variation rate** of the Services Sector Turnover General Index **decreases 2.5%** in the first two months of the year.

- **Employed personnel decreases 2.6%**, as compared with February the previous year.

 Turnover in the services sector registers positive interannual rates in five Autonomous Communities. Employment decreases in all of the Autonomous Communities.

#### Evolution of turnover in the Services sector

Turnover in the market Services sector registered a decrease of 0.9% in February 2010, as compared with the previous year, more than three points above that registered in January.

By sector, the interannual variation of *Trade* was 0.9%, whereas *Other Services* presented a rate of -4.4%.

Within Other Services, all of the sectors presented negative interannual rates in February. *Professional, scientific and technical activities* presented the most pronounced drop (-7.5%), followed by *Information and communications* (-6.2%), *Accommodation* (-4.0%), *Administrative and support service activities* (-3.4%) and *Transport and storage* (-1.1%).


Most of the activities in the Services sector experienced a decrease in turnover in February, in the interannual rate.

• **Trade.** The greatest decreases were registered in *Wholesale trade of IT and communications equipment* (-9.4%) and in *Wholesale trade of other machinery, equipment and supplies* (-9.1%). The only activities that presented increases were the Sale of motor vehicles, motorcycles and spare parts (19.1%), *Wholesale of fuels, metals and others* (3.1%), *Wholesale of food, beverages and tobacco* (1.2%) and the *Retail trade* (0.1%).

• Other Services. The activities that presented the greatest decreases were Motion picture, television programme production and music publishing activities (-21.0%) and Technical architecture and engineering services; technical trials and analysis (-17.5%). In turn, those which registered the greatest increases were Employment-related activities (11.4%) and Storage and transport-related activities (2.9%).

#### Year-to-date average rates

The average rate of the Services Sector Turnover General Index stood at -2.5% in the first two months of the year. All of the sectors registered negative average rates during this period.




#### General Index and by turnover sector

#### Variation rates adjusted for the calendar effect

The General Index of Services sector turnover was not affected by the calendar effect in the month of February. The interannual variation of the adjusted index stood at two points above that registered in January.

#### **Evolution of employed personnel**

Employment in the Services sector experienced an interannual decrease of 2.6% in the month of February. This indicated an increase of eight tenths as compared with the rate registered in January.

In the first two months of the year, the average rate of the General Index of employed personnel stood at -3.0%.

All of the sectors experienced interannual decreases, with the greatest being recorded in *Information and communications* (-3.9%) and *Professional, scientific and technical activities* (-3.2%).


#### National employed personnel indices



#### Autonomous Communities. Turnover variation rates

In February 2010, five Autonomous Communities registered positive interannual variation rates: La Rioja (5.0%), Cantabria (4.7%), Cataluña (2.1%), Principado de Asturias (2.0%) and Extremadura (0.5%).

In turn, Canarias presented the greatest negative rate (-7.9%).




#### Turnover index by Autonomous Community.

#### Autonomous Communities. Employed personnel variation rates

Employment in the services sector presented a generalised decrease in all of the Autonomous Communities. Principado de Asturias (-0.3%), Castilla y León and La Rioja (both with -0.6%), and Cantabria (-0.9%) presented the smallest decreases.

In turn, Canarias (-4.1%) and Comunitat Valenciana (-4.0%) were the Communities with the greatest decreases.
