Services Sector Activity Indicators. Base 2005 April 2009. Provisional data


Turnover of the Services sector decreases 20.1% in April, as compared with the same month of 2008


Employed personnel decreases 6.8% in the interannual rate


Turnover of the market Services sector registered a decrease of 20.1% in April, as compared with the same month of 2008. All sectors experienced a decrease in turnover in interannual terms. Trade presented the greatest decrease (-23.4%), followed by Transport (-18.2%), Services Provided to Companies (-12.1%), Tourism (-8.7%) and Information Technologies (-6.3%) sectors.

After adjusting for the calendar effect, given that **Easter week** took place in the month of April this year, whereas in 2008 it took place in March, the general index of turnover recorded a smaller interannual decrease of 17.3%. The same occurs with Trade (–20.1%), Transport (–15.5%) and Services rendered to companies (-13.1%). Information Technologies hardly showed any change, whereas Tourism experienced a larger decrease (–12.6%).

Turnover by activity

All activities in the Service sector saw an interannual decrease in turnover in April. Those presenting the smallest decreases were Telecommunications (-0.2%) and Office management activities (-1.0%). The largest decreases were recorded for the activities Sale of motor vehicles, motorcycles and spare parts (-41.8%), for Employment-related activities (-41.7%) and for Wholesale trade in fuels, metals and others (-41.4%).

Employment in the Services sector decreases 6.8% in the interannual rate

Employment in the Services sector experienced an interannual decrease of 6.8% in the month of April. There were job losses in all sectors. Services provided to companies was the sector with the greatest decrease, with a rate of -9.5%, followed by the Tourism (-7.3%), Trade and Transport (both with a rate of -5.9%), and Information technologies with a rate of -2.0%


Evolution of work was negative in all activities. Those presenting the smallest decreases were Computer programming and consultancy (-0.3%), Wholesale trade in agricultural raw materials and live animals (-0.6%), and Radio and television programming and broadcasting (-0.7%). Employment-related activities experienced the largest interannual decrease (-38.0%).

Turnover of the Services sector decreases in all Autonomous Communities

Turnover of the Services sector decreased in April in all of the Autonomous Communities, as compared with the same month the previous year. The Communities registering the lowest decreases in constant terms were Extremadura (–10.9%), Cantabria (–13.1%) and Galicia (–14.4%).

In turn, those with the greatest decreases were Comunitat Valenciana (-22.9%), Comunidad de Madrid (-22.2%), País Vasco (-22.1%) and Cataluña (-22.0%).

Interannual variation rates of the General Index by Autonomous Community. Turnover




Employment decreases in all Autonomous Communities

Employment decreased in April in all of the Autonomous Communities, as compared with the same month the previous year. The Communities presenting the smallest decreases were Cantabria (-3.5%) and Galicia and Principado de Asturias (both with -3.6%).

In turn, the Communities with the greatest decreases were Comunitat Valenciana (-8.9%) and Canarias (-8.2%).

Methodological note

New National Classification of Economic Activities 2009 (CNAE-2009)

The European Parliament and Council passed the new classification of economic activities for statistical purposes within the European Union, known as NACE Rev.2, on 20 December 2006, via Regulation (EC) no. 1893/2006. This Regulation also stipulates the use of the new classification in the statistics of the community scope, for the purpose of ensuring the harmonised implementation thereof. Among these statistics are the short-term statistics, which include the *Services Sector Activity Indicators (SSAI)*.

In order to be able to adapt the European classification to their reality, each Member State has compiled national versions that are compatible with NACE Rev.2. The national version of NACE Rev.2 in Spain is CNAE-2009, passed by Royal Decree 475/2007, of 13 April 2007 (BOE of 28 April 2007).

The adaptation to the new classification has caused changes in the *Services Sector Activity Indicators* survey. For some activities, the new classification has only caused a change in code, and not in content; in other cases, however, some activities have changed to belong to different branches or sectors. Thus, to quote an example, Publishing has moved from the Industry sector to the Services sector; therefore, in this survey, this activity is included within the sector of Information Technologies. On the other hand, with the new classification, the Services sector gains more relevance; this has caused the increase in the number of activities disseminated in this indicator.

On 29 May 2008, Commission (EC) Regulation no. 472/2008 was passed on the transfer in NACE Rev.2 of short-term statistics, establishing the European guidelines for the dissemination of results in the new classification. Pursuant to this Regulation, beginning with reference month January 2009, the indices will begin to be published in the new classification, CNAE-2009. Likewise, in order to guarantee the comparability of the information over time, the INE will publish the retrospective series in this new classification in INEbase.
