
**La variación mensual de la cifra de negocios<sup>1</sup> del Sector Servicios de Mercado es del 1,3% si se eliminan los efectos estacionales y de calendario**

**La tasa anual se sitúa en el 4,2% en la serie corregida de efectos estacionales y de calendario, y en el 4,9% en la serie original**

**Evolución mensual de la cifra de negocios del Sector Servicios de Mercado**

La variación mensual del índice general de la cifra de negocios del Sector Servicios de Mercado entre los meses de junio y mayo, eliminando los efectos estacionales y de calendario, es del 1,3%. Esta tasa es un punto y tres décimas superior a la de mayo.

Adjusted for seasonal and calendar effects. Monthly rate**



Si se eliminan los efectos estacionales y de calendario, *Comercio* registra una tasa mensual del 1,5% y *Otros Servicios* del 1,2%.

Por sectores, *Actividades profesionales, científicas y técnicas* (2,3%) e *Información y comunicaciones* (2,1%) presentan los mayores aumentos. Por su parte, *Actividades administrativas y servicios auxiliares* (-0,8%) y *Venta y reparación de vehículos y motocicletas* (-0,4%) son los únicos que registran descensos mensuales.



## Evolución anual de los índices de cifra de negocios del Sector Servicios de Mercado

El Índice general de la cifra de negocios del Sector Servicios de Mercado corregido de efectos estacionales y de calendario experimenta una variación del 4,2% en junio respecto al mismo mes de 2015. Esta tasa es un punto y tres décimas superior a la registrada en mayo.

La serie original presenta una variación anual del 4,9%, lo que supone seis décimas más que la registrada en mayo.

Si se eliminan los efectos estacionales y de calendario, Comercio sube un 4,0% respecto a junio de 2015 y Otros Servicios un 4,9%.

Todos los sectores registran tasas anuales positivas. Venta y reparación de vehículos y motocicletas (9,6%) es el que más sube.



## Resultados por comunidades autónomas. Tasas de variación anual de la cifra de negocios. Serie original

Todas las comunidades autónomas aumentan su cifra de negocios del Sector Servicios de Mercado en junio respecto al mismo mes del año anterior.

Illes Balears (8,7%) y Cantabria (8,3%) son las que más suben. Por su parte, Principado de Asturias y Castilla y León (ambas con un 2,0%) registran los menores aumentos.

La ocupación aumenta un 2,0% en tasa anual en el *Comercio* y un 2,6% en *Otros servicios*.


