
**La variación mensual de la cifra de negocios<sup>1</sup> del Sector Servicios de Mercado es del 0,6% si se eliminan los efectos estacionales y de calendario**

**La tasa anual se sitúa en el 4,1 % en la serie corregida de efectos estacionales y de calendario, y en el 4,5% en la serie original**

**Evolución mensual de la cifra de negocios del Sector Servicios de Mercado**

La variación mensual del índice general de la cifra de negocios del Sector Servicios de Mercado entre los meses de septiembre y agosto, eliminando los efectos estacionales y de calendario, es del 0,6%. Esta tasa es siete décimas superior a la de agosto.

Adjusted for seasonal and calendar effects. Monthly rate**



Si se eliminan los efectos estacionales y de calendario, *Comercio* registra una tasa mensual del 0,4% y *Otros Servicios* del 0,9%.

Por sectores, *Actividades administrativas y servicios auxiliares* (1,4%) y *Hostelería e Información y comunicaciones* (ambas con 1,3%) presentan los mayores aumentos. Por su parte, *Comercio al por menor* (0,3%) y *Transporte y almacenamiento* (0,4%) registran los menores incrementos mensuales. *Comercio al por mayor e intermediarios del comercio* (0,0%) se mantiene.



## Evolución anual de los índices de cifra de negocios del Sector Servicios de Mercado

El Índice general de la cifra de negocios del Sector Servicios de Mercado corregido de efectos estacionales y de calendario experimenta una variación del 4,1% en septiembre respecto al mismo mes de 2015. Esta tasa es seis décimas inferior a la registrada en agosto.

La serie original presenta una variación anual del 4,5%, lo que supone 1,5 puntos por debajo de la registrada en agosto.

Si se eliminan los efectos estacionales y de calendario, *Comercio* sube un 3,6% y *Otros Servicios* un 5,1% respecto a septiembre de 2015.

Todos los sectores registran tasas anuales positivas. *Venta y reparación de vehículos y motocicletas* (11,5%) es el que más sube.



## Resultados por comunidades autónomas. Tasas de variación anual de la cifra de negocios. Serie original

Todas las comunidades autónomas aumentan su cifra de negocios del Sector Servicios de Mercado en septiembre.

La Rioja (10,3%) y Cantabria (9,7%) son las que más suben. Por su parte, Andalucía (2,5%) y Principado de Asturias (2,9%) registran los menores incrementos.

## Evolución de la ocupación

La ocupación aumenta un 2,1% en tasa anual en el *Comercio* y un 2,8% en *Otros servicios*.


