
The monthly variation of turnover¹ for the Market Services Sector is 2.1%, after adjusting for seasonal and calendar effects

The annual rate stands at 7.3% in the series adjusted for seasonal and calendar effects and at 7.7% in the original series

Monthly evolution of the turnover for the Market Services Sector

The monthly variation of the general index of the turnover for the Market Services Sector between November and October, after adjusting for seasonal and calendar effects, was 2.1%. This rate is 2.9 points higher than that registered in October.

Corregido de efectos estacionales y de calendario. Tasa mensual**




¹ As explained in the methodology for this value index, the information is presented in current terms (nominal terms), that is, without adjusting the effects in the price variation thereof.

After adjusting for seasonal and calendar effects, *Trade* increased by 2.7% and *Other services* did so by 1.3%.

All sectors registered positive monthly rates; *Wholesale trade and commission trade* (2.3%) and *Professional, scientific and technical activities* (2.1%) recorded the highest increases.

In turn, the lowest increases were in *Accommodation* (0.5%) and *Information and communications* (1.0%).

In a more detailed analysis we can observe the branches of activity that registered the highest monthly rates and those with the lowest increases in the month of November.


Annual evolution of the turnover index for the Market Services Sector

The general index of the turnover for the Market Services Sector after adjusting for seasonal and calendar effects showed a variation of 7.3% in November as compared with the same month of 2016. This rate is 2.1 points higher than that registered in October.

The original series registered an annual variation of 7.7%, which is 1.8 points higher than that registered in October.

After adjusting for seasonal and calendar effects, *Trade* increased by 7.6% and *Other Services* by 6.8% as compared with November 2016.

All sectors registered positive annual rates. *Sale and repair of vehicles and motorcycles* (12.2%) and *Professional, scientific and technical activities* (11.8%) increased the most.



Results by Autonomous Community. Annual turnover variation rates. Original series

All the Autonomous Communities increased their turnover for the Market Services Sector in November as compared with the same month of 2016.

Comunidad de Madrid (9.7%), Illes Balears (9.4%) and Cantabria (8.7%) increased the most. In turn, Castilla y León (4.2%), Extremadura (5.6%) and Aragón (5.7%) registered the lowest increases.

Evolution of employment

Employment in the Market Services Sector increased by 2.5% in November as compared with the same month of the previous year. This rate is two tenths lower than that registered in October.

The employment rate increased by 2.1% in *Trade* and by 2.7% in *Other services*.


