Services Sector Activity Indicators (SSAI). Base 2005 December 2012. Provisional data

The annual rate of turnover for the market Services Sector stands at -7.0% in December, as compared with -7.8% in November

Employment decreases 2.9% in December as compared with the same month of 2011

In 2012, the annual variation of turnover for the market Services Sector stands at -5.3%, whereas that of employment is -2.8%

Annual performance of turnover for the Services Sector

Turnover in the market Services Sector experienced an interannual variation of -7.0% in December, as compared with the same month of the previous year. This rate is almost eight tenths over that registered in November.

Trade presented an annual rate of -6.5% and an effect of -4.337. In turn, Other Services experienced a variation of -8.2%, with an effect of -2.692 on the general index.

In December, all sectors presented a negative effect on the general index. The sectors with the greatest influence were:

• Retail trade, with an annual rate of -6.8% and an effect of -1,698.

caused by the negative performance of almost all activities comprising it; among them, worth noting, the.

- Wholesale trade and intermediaries, with a variation of –4.2% and an effect of –1.549 on the general index, due to the negative performance in almost every activity comprising this sector. Among them highlighted Wholesale of household goods. Worth noting the positive performance of Wholesale of fuels, metals and others.
- Sale and repair of motor vehicles and motorcycles, with an annual variation of -19.7% and an effect of -1.090 on the general index, determined by the negative performance of the two activities comprising it. Among them, highlighted Sale of motor vehicles, motorcycles and spare parts.
- **Professional, scientific and technical activities**, with an annual variation of -13.2% and an effect of -0.978, with the decrease of all activities.

A more detailed analysis showed the activities that most affected the annual rate of the general index of Services Sector turnover in the month of December.



The variation of the Services Sector Turnover General between December and November was 9.1%. Almost one point higher than that registered in 2011.

Monthly rate performance of the Service Sector Turnover (month-on-month variation of December over November of the same year)




Year-to-date average rates

In 2012, the average rate of the Services Sector Turnover General Index registered a variation of **-5.3%**, as compared with 2011. This rate was -5.3% in Trade and -5.2% for Other Services.

¹ To contribute to the analysis and interpretation of data, it has been included this section with the performance of the Services Sector Turnover in the last years. The monthly rates of this type of series may have some degree of seasonal behaviour, therefore it is recommended to evaluate it in relation to the item of data for the same month in previous years.

By sectors, the average rate of the Services Sector Turnover experienced a negative variation rate in all sectors.


Annual and average turnover rates General index and by sectors



Performance of the Services Sector Turnover adjusted for the calendar effect

After eliminating the calendar effect, that is, the difference between the number of working days in a given month in different years, the annual variation of the General Index of Services Sector Turnover stood at **–6.2%** in December, representing more than one-and-a-half points than that registered in the previous month.

Performance of employed personnel

Employment in the Services Sector experienced an annual variation of –2.9% in December, as compared with the same month of the last year. This rate was one tenth above that registered in November.

Trade registered a variation of -2.3% and an effect of -0.986. Other Services registered a variation of -3.4% and an effect of -1.913.

All sectors presented a negative effect on the general index of employed personnel. Those with the greatest influence were:

- **Accommodation**, with a variation of -3.4% and an effect of -0.503, caused by the decrease in the two activities comprising this sector, highlighting *Food and beverages* service activities.
- Administrative and support service activities, with an annual rate of -3.5% and an effect of -0.500, motivated by the negative performance in all activities comprising this sector. Highlighting, among them *Cleaning activities*.
- Wholesale trade and intermediaries, with a variation of -2.8% and an effect of -0.424, caused by the decrease in all activities comprising this sector.
- **Transport and storage**, with a variation of -3.4% and an effect of -0.410, due to the general decrease in the activities comprising the sector. Highlighted the negative performance of the employment in *Freight transport by road and removal services*.
- **Retail trade**, with an annual variation of -1.4% and an effect of -0.346.
- **Professional, scientific and technical activities**, with an annual rate of -2.7% and an effect of -0.310, motivated by the negative performance in all activities comprising this sector.

In 2012, the average rate of the General Index of employed personnel stood at -2.8%, as compared with the previous year. This rate was -2.1% in Trade and it was -3.3% in Other Services.

Annual and average employmenet rates General index and by sectors




Autonomous Communities. Turnover variation rates

All Autonomous Communities presented a negative performance of Turnover in the Service Sector in December.

The greatest decreases were registered in Comunidad Foral de Navarra (-12.0%) and Extremadura (-10.0%). In turn, the smallest decreases were registered in Región de Murcia (-2.1%) and Cantabria (-4.7%).

Annual and average turnover rates General Index by Autonomous Community




Autonomous Communities. Variation rates of employed personnel

All Autonomous Communities registered negative annual rates in employment in December.

The greatest decreases were in Principado de Asturias (-4.0%) and Comunidad Foral de Navarra (-3.8%). In turn, the smallest decreases were registered in Pais Vasco (-1.3%) and Cataluña (-2.2%).
