Business Confidence Indicators (BCI)

Fourth quarter of 2020

The Harmonized Business Confidence Index (HBCI) increases 10.5% in the fourth quarter of 2020 as compared with the third quarter

8.1% of business establishments foresee a favourable quarter and 49.4% are pessimistic about the performance of their business

Main results


- The Harmonized Business Confidence Index increases 10.5% in the fourth quarter of the year compared to the third. It should be noted that the collection of information for the fourth quarter was carried out from September 15 to October 5, while the third quarter took place at the end of the state of alarm (from June 15 to July 6).
- All sectors increase their confidence compared to the third quarter. Construction presented the highest increase (14.0%). Trust also grows in all sizes of establishments. The one with more than 1000 employees registered the highest increase (15.5%).
- The balance of expectations for the fourth quarter (difference between the optimistic responses of the business managers minus the pessimistic ones) is −41.3 points, with an improvement compared to the third quarter, which was −47.2 points.
- Transport and Acommodation continues to be the sector with the worst expectations (-65.5 points for the fourth quarter). By size, businesses with fewer than 10 employees present the worst prospects (-52.1).
- Confidence suffers more in the autonomous communities in which tourism is a fundamental part of their economy. In Illes Balears the balance of expectations is −67.0 points and in the Canary Islands it is −56.8.
- Regarding the situation of the quarter that ended, the balance (-38.8 points) improves the expectations previously expressed (which were -47.2).

Evolution of the Harmonized Business Confidence Index

The Harmonized Business Confidence Index (HBCI) increases by 10.5% in the fourth quarter of 2020 as compared with the third quarter.

Opinions regarding the coming quarter (Expectations)


8.1% of business establishments managers considered that the performance of their businesses during the fourth quarter of 2020 would be favourable, while 49.4% thought it would be unfavourable. The remaining 42.5% thought that it would be normal.

The difference between the percentage of favourable and unfavourable responses, know a Expectations Balance, stood at -41.3 points for Spain as a whole, as compared with the -47.2 in the previous quarter.

Opinions regarding the ending quarter (Situation)


10.0% of business establishment managers expressed a favourable opinion regarding the performance of their businesses in the third quarter of 2020. In turn, 48.8% had an unfavourable opinion.

The difference between the percentage of favourable and unfavourable responses referring to the ending quarter, known as *Situation Balance*, stood at -38.8 points. This figure improves Expectations previously expressed for that quarter, which stood at -47.2 points.


Evolution of the Situation Balance Fourth Quarter 2020



Harmonized Business Confidence Index by activity sector

The five sectors analyzed increased confidence with respect to the previous quarter. *Construction* (14.0%) registered the greatest increase. On the other hand, *Trade* (6.6%) registered the lowest increase.


General Index and by activity sector Fourth Quarter 2020. Quarterly rate



Harmonized Business Confidence Index by size of establishments

The five sizes of establishments analyzed presented an increase in confidence, as compared with the previous quarter. *1000 or more employees* (15.5%) showed the largest increase and *Less than 10 employees* (9.0%) the lowest increase.

General index and by size of establishment Fourth Quarter 2020. Quarterly rate




Harmonized Business Confidence Index. Results by Autonomous Communities

Business confidence increased in the fourth quarter of 2020 as compared with previous quarter in all autonomous communities.

The largest increases were recorded in Cantabria (16.2%) and Aragón, Principado de Asturias, Cataluña and Galicia (all of them 12.6%).

Review and update of data

Data published today are final and will not be subject to further revision. There have been no updates to previous publications. All results are available on INEBase.

Methodological note

The objective of this survey is to find out, at a given time, the vision that establishment managers have about their situation.

The BCI survey collects opinions from establishment managers regarding the performance of their businesses for each last quarter and on their expectations for each coming quarter.

The methodology is based on the Japanese TANKAN index, that is, there is no weighting or elevation depending on the characteristics of the establishment since the opinion of each informant counts equally.

The survey methodology enables the integration of analogous data compiled by the statistics services of the Autonomous Communities, once their consistency is checked so they can be incorporated into the general process of the survey. There are currently agreements signed to this effect with Andalucia, Illes Balears, Canarias, Castilla y León, Cataluña, la Rioja, Extremadura and Comunitat Valenciana.

Type of survey: quarterly continuous survey.

Base period: First quarter of 2013.

Population scope: all establishments whose main activity is included in the following sections of CNAE-2009: B to N (both included, except for division 70), R (only divisions 92 and 93) and S (only divisions 95 and 96).

Geographical scope: the entire national territory except Ceuta and Melilla.

Sample size: The sample is representative both nationally and by Autonomous Community and is made up of around 8000 establishments.

Reference period: the reference period is quarterly and questions are asked about the quarter ending and about the coming quarter.

Collection method: completion of the questionnaire by establishment managers themselves using one of the following methods: internet (IRIA system), e-mail, fax, telephone or by postal mail.
