## The cost per hour worked increases 9.1% in the second quarter of 2009 with respect to the same period of 2008

# The increase stands at 5.7% if adjusted for calendar and seasonal effects

The cost per hour worked increased 9.1% in the second quarter as compared with the same period of 2008. After adjusting for seasonal and calendar effects, the interannual rate stood at 5.7%.

The gross figure shows a greater increase as a result of the lower number of hours worked during the quarter, due to the fact that Easter Week was held in the month of April this year.


