
Harmonised Labour Cost Index (HLCI). Base 2020 Third quarter 2023 Provisional data

The quarterly variation in the cost per hour worked, after eliminating calendar and seasonal effects, is 0.9%

The cost per hour worked increased by 5.7% in the annual rate in the series adjusted for calendar and seasonal effects, and 5.4% in the original series

Quarterly variation of the Index

The quarterly variation of the HLCI –which measures the labour cost per hour worked while keeping constant the structure by branch of activity– stood at 0.9% between the third and second quarter of 2023, after adjusting for seasonal and calendar effects.



Labour Cost Index adjusted for seasonal and calendar effects

By cost components, in seasonally and calendar adjusted data, wage costs showed a variation of 1.0%, and other costs of 0.5%.

After adjusting for seasonal and calendar effects, the quarterly rate was 3.1% due to the lower number of hours worked during the holiday period in the third quarter as compared to the second.



Annual variation of the Index

The cost per hour worked increased by 5.4% in the third quarter of 2023 compared to the same period of the previous year.

The annual variation of the cost per hour was 5.7%, after adjusting for seasonal and calendar effects.

By cost component, wage costs showed an annual variation of 4.9% in corrected data, while other costs increased by 8.0%.

Results by activity sections

The sections that register the highest annual increases on the third trimester are *Real estate activities* (13.0%), *Information and communications* (8.2%) and *Artistic, recreational and entertainment activities* (7.8%).

For their part, the lowest increases are in *Extractive industries* (0.3%), Electricity, gas, steam and air conditioning supply (1.8%), and *Financial and insurance activities* (3.0%).


If seasonal and calendar effects are eliminated, the activities with the highest annual rates are *Real estate activities* (13.2%), *Information and communication* (8.3%) and *Other services* (8.0%).

For their part, the lowest increases were registered in *Extractive industries* (2.7%), *Financial* and *insurance activities* (3.7%) and *Education* (3.9%).

Revision and updating of data

Coinciding with today's publication, the HLCI provisional data of the second quarter of 2023 have been updated. The final index stands at 107.7 points.

The quarterly variation of the original series for that quarter stood at 9.0%, and that of the adjusted index was at 1.5%. In turn, the annual rate of the original series is 6.5% and that of the index corrected for calendar and seasonal effects is 5.6%. The results are available at INEBase.

Methodological note

The Harmonised Labour Cost Index (HLCI) is a quarterly continuous statistical operation whose objective is to provide a common and comparable measure of labour cost per hour worked for the whole of the European Union, allowing the monitoring of the evolution of said labour costs.

Indices with base 2020 are provided for total labour costs, wages and salaries and other costs net of subsidies received for the use of labour factor (includes social contributions payable by employers and non-wage payments). The index for total labour cost is also provided excluding extraordinary payments and delayed payments.

Type of operation: Statistics presented mainly in the form of indices.

Base year: 2020.

Population scope: Employees in local units.

Sources of information: The Quarterly Labour Cost Survey which is conducted on the basis of the Social Security contribution accounts. General Scheme: Sections B to S of CNAE-09 and Special Scheme for Seafarers: Sea Transport (Division 50 of CNAE-09). In order to cover all employees of the general government, information from the DARETRI file is used.

Geographical scope: the entire national territory.

Reference period of the results: the calendar quarter.

Calculation method: Chained Laspeyres.
