## Industrial Turnover Indices (ITI). Base 2010 July 2013. Provisional data


The annual rate of the General Industry Turnover Index stands at -2.1% in the seasonally adjusted series and at 0.4% in the original series

## The monthly variation stands at -1.2%, after adjusting the seasonal and calendar effects

In July, the General Industry Turnover Index (ITI) registered a 0.4% variation, as compared with the same month of 2012. This annual rate is almost four points higher than that of June.

After adjusting the seasonal and calendar effects, the rate was -2.1%, almost two points lower than that of June.

#### Annual evolution of the turnover by economic destination of the goods

Three out of the five industrial sectors analysed registered negative annual rates in July. Durable consumer goods registered the greatest decrease (–8.2%).

After adjusting the seasonal and calendar effects, Capital goods (2.0%) and Non-durable consumer goods (0.1%) were once again the sectors that registered positive rates and Durable Consumer goods (–11.2%) also registered the greatest decrease.



#### Annual evolution of the turnover, by market

By geographical destination of sales, Domestic market registered a negative annual rate in July (–2.3%), whereas the remaining markets registered positive rates.

The greatest increase was registered in the Foreign market Euro zone, in which the invoicing increased 4.7%, followed by the non-Euro zone, with a 3.8% annual increase.

## Annual rate of ITI General index and by market




#### Results by Autonomous Community. Annual variation rates of turnover

In July, the turnover remained unchanged in Castilla y León, as compared with July 2012. In turn, it decreased in half the Autonomous Communities and it increased in the other half.

The greatest increase was registered in Galicia (10.8%), whereas Illes Balears (–9.5%) and País Vasco (–9.0%) registered the greatest decreases.


#### General index by Autonomous Community Annual rate of Industry Turnover



#### Monthly evolution of the ITI, adjusted for seasonal and calendar effects

The monthly variation of the General Industry Turnover Index between June and July was –1.2%, after adjusting the seasonal and calendar effects. This rate was one-and-a-half points lower than that registered in June.


## Turnover general index Adjusted for season and calendar effects. Monthly rate



#### Monthly evolution by destination of the goods

After adjusting the seasonal and calendar effects, four out of the five sectors registered negative monthly rates. Capital goods (0.7%) was the only sector that increased its turnover rate adjusted for seasonal and calendar effects as compared with the previous month.
