Industrial Turnover Indices (ITI). Base 2010 August 2013. Provisional data

The annual rate of the General Industry Turnover Index stands at –7.1% in the seasonally adjusted series and at –9.6% in the original series

The monthly variation stands at 2.2%, after adjusting the seasonal and calendar effects

In August, the General Industry Turnover Index (ITI) registered a -9.6% variation, as compared with the same month of 2012. This annual rate is ten points lower than that of July.

After adjusting the seasonal and calendar effects, the rate was -7.1%, more than five points lower than that of July.

Annual evolution of the turnover by economic destination of the goods

All industrial sectors analysed registered negative annual rates in August. Energy (–19.3%) and Durable consumer goods (–18.2%) registered the greatest decreases.

After adjusting the seasonal and calendar effects, all the annual rates remain negative, and Energy (-18.7%) and Durable consumer goods (-14.9%) were the sectors that decreased the most.

Annual evolution of the turnover, by market

By geographical destination of sales, Foreign market Euro zone was the only one that registered a positive annual rate in August (-0.3%).

The remaining markets registered negative rates. The greatest decrease was registered in the Domestic market, in which the invoicing decreased 13.0%.

Results by Autonomous Community. Annual variation rates of turnover

The turnover decreased in all the Autonomous Communities, as compared with August 2012.

The greatest decreases were registered in Illes Balears (–26.8%) and Extremadura (– 23.1%).

Monthly evolution of the ITI, adjusted for seasonal and calendar effects

The monthly variation of the General Industry Turnover Index between August and July was 2.2%, after adjusting the seasonal and calendar effects. This rate was more than three points higher than that registered in July.





Monthly evolution by destination of the goods adjusted for seasonal and calendar effects

After adjusting the seasonal and calendar effects, four out of the five sectors registered positive monthly rates, highlighting Durable consumer goods (23.0%). The only sector that decreased its turnover rate adjusted for seasonal and calendar effects was Capital goods (– 1.8%)
