Industrial New Orders Received Indices (INORI). Base 2005
September 2012. *Provisional data*

The annual rate of the Industrial Turnover Index stands at –8.2% in September, as compared with 4.0% in August

The annual variation rate of New Orders Received is –5.7%, as compared with 1.7% in August

Evolution of Industrial Turnover

The Industrial Turnover Index (ITI) experienced an annual variation of –8.2% in September, more than twelve points below that registered in August.

By economic destination of the goods, the industrial sectors that presented a greater negative effect on the general index were:

- **Capital goods**, with an annual variation of –19.5% and an effect of –4.627, caused, mainly, by the drop in *Manufacture of motor vehicles, trailers and semi-trailers*.
- **Intermediate goods**, with an annual rate of –10.8% and an effect of –3.915, caused by the decreases registered in almost all of the activities comprising this sector. Among them, highlighting, by their influence, were *Metallurgy; manufacture of iron, steel and ferro-alloy products* and *Manufacture of other non-metallic ore products*.
- **Non-durable consumer goods**, with an annual rate of –6.1% and an effect of –1.666. Almost all activities of this sector presented a negative annual evolution in its turnover. Among them, highlighting, by its effect, *Manufacture of other food products (except grain mill products and food for animals.)*

In turn, **Energy** was the only industrial sectors that presented a positive effect on the general index, with an annual variation of 24.8% and an effect of 2.495, mainly due to the increase registered in the *Manufacture of coke and refined petroleum products*.

A more detailed analysis showed the activities that most affected the annual rate of the ITI in the month of September.

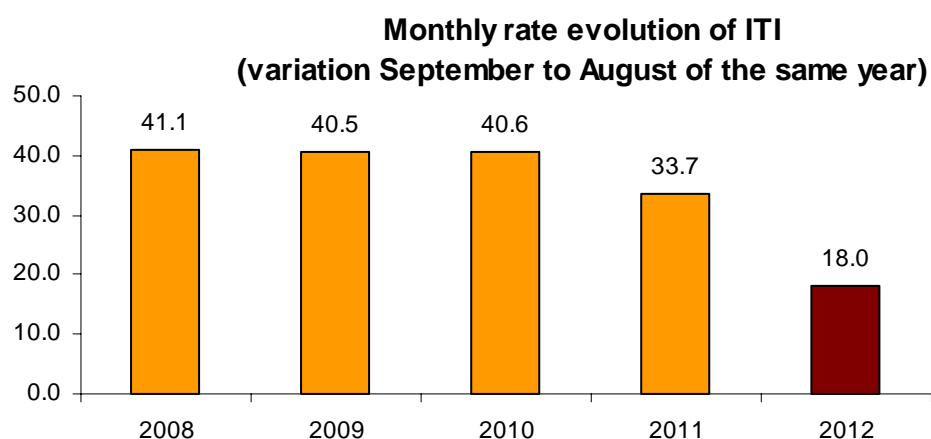

Monthly rate performance ¹

The variation of the Industrial Turnover Index between September and August was 18.0%. This month-on-month rate of September was the smallest in the last five years.



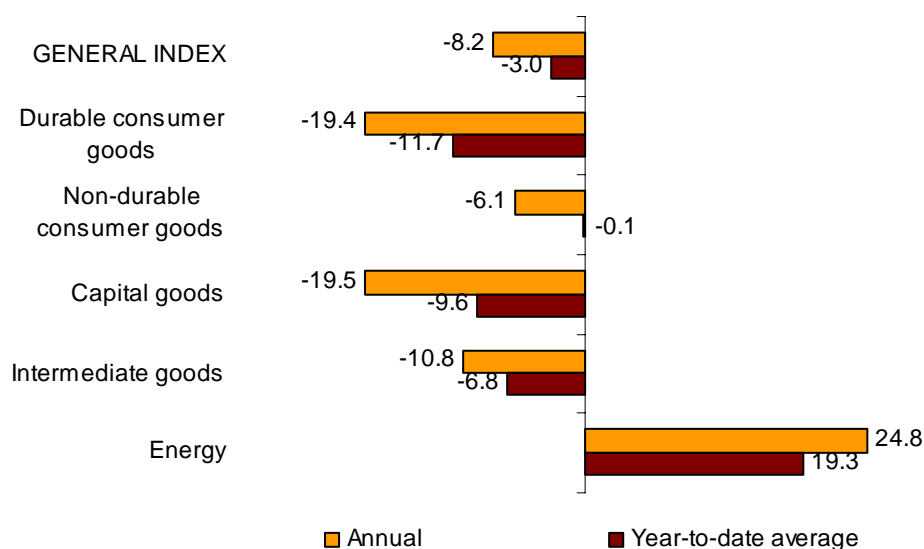

Year-to-date average rates

The average rate of the Industrial Turnover Index registered a variation of **-3.0%** in the period from January to September, as compared with the same period of 2011. By economic destination of the goods, the rate is negative in all industrial sectors, except in Energy.

General index and by economic destination of the goods

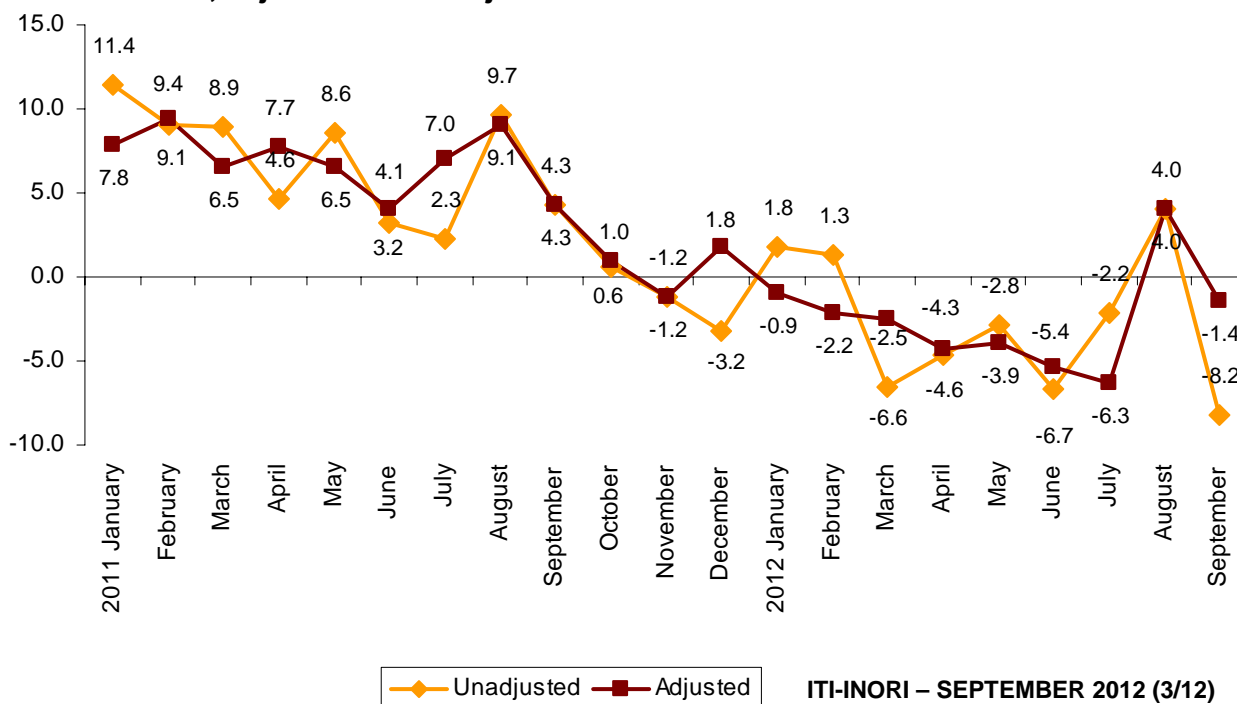


Evolution of the ITI, adjusted for the calendar effect

After adjusting for the calendar effect, that is, the difference between the number of working days in a given month in different years, **the interannual variation of the ITI in the month of September was -1.4%, representing almost five-and-a-half points less than in August.**

Annual evolution of Industrial New Orders Received

The Industrial New Orders Received Index (INORI) experienced an annual variation of – 5.7% in September, almost seven-and-a-half points below that registered in August.

By economic destination of the goods, the industrial sectors that presented the greatest negative effects on the general index were:

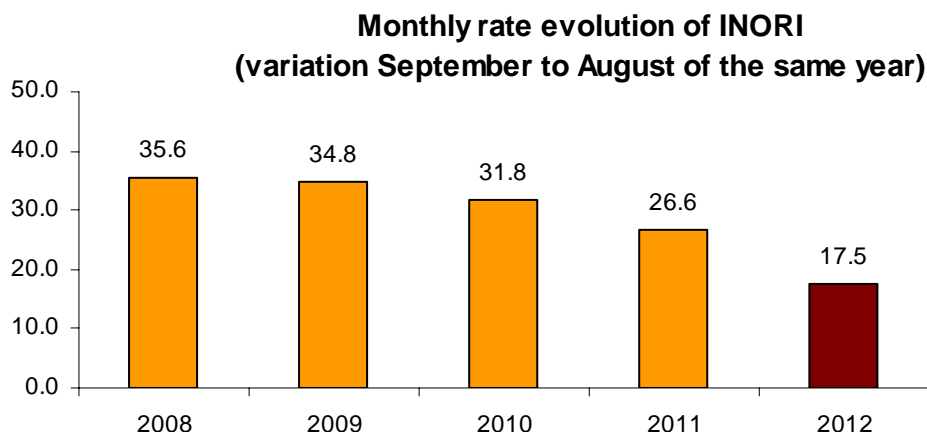
- **Intermediate goods**, with an annual variation of –11.5% and an effect of –4.292, motivated by the decreases registered in all activities comprising this sector. Among them, highlighting the decreases observed in *Metallurgy, manufacture of iron, steel and ferro-alloy products* and in *Manufacture of non-metallic mineral products*.

- **Capital goods**, with an annual variation of –11.6% and an effect of –2.505, caused by the negative evolution in new orders received in the most of the activities comprising this sector. Among them highlighted the *Manufacture of motor vehicles, trailers and semi-trailer*. Among the increases, worth noting the *Naval, railway, aircraft and spacecraft construction*. *Combat vehicles* and in *Repair and installation of machinery and equipment*.

In turn, **Energy** was the only industrial sector that presented positive effect on the general index, with an annual variation of 24.8% and an effect of 2.546, mainly due to the increase registered in the *Manufacture of coke and refined petroleum products*.

Monthly rate performance²

The variation of the New Orders Received between September and August was 17.5%. This month-on-month rate was the smallest that registered in the last five year.

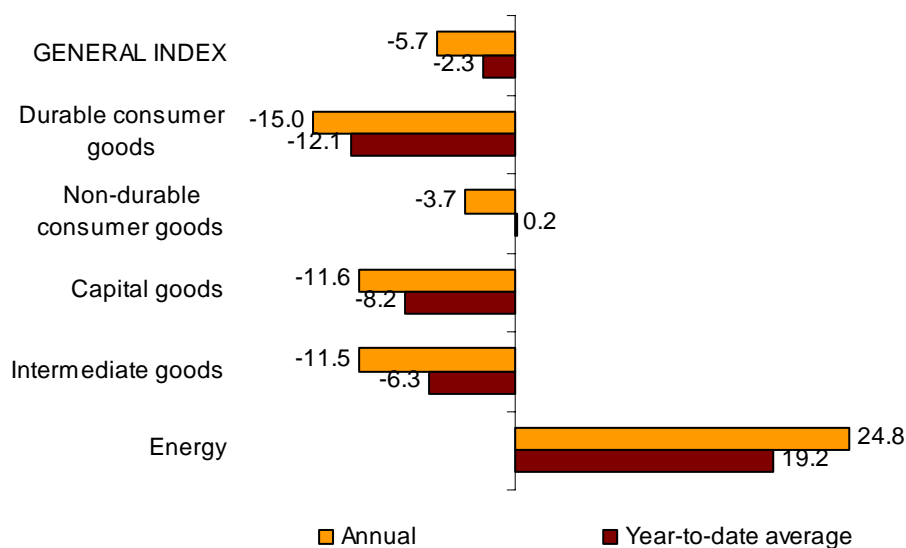

Year-to-date average rates

The average of the General Industrial New Orders Received Index in the first nine months of the year registered a variation rate of **-2.3%**, as compared with the same period of 2011. By economic destination of the goods, this variation rate was negative, in all of the industrial sectors, except Energy and Non-durable consumer goods.

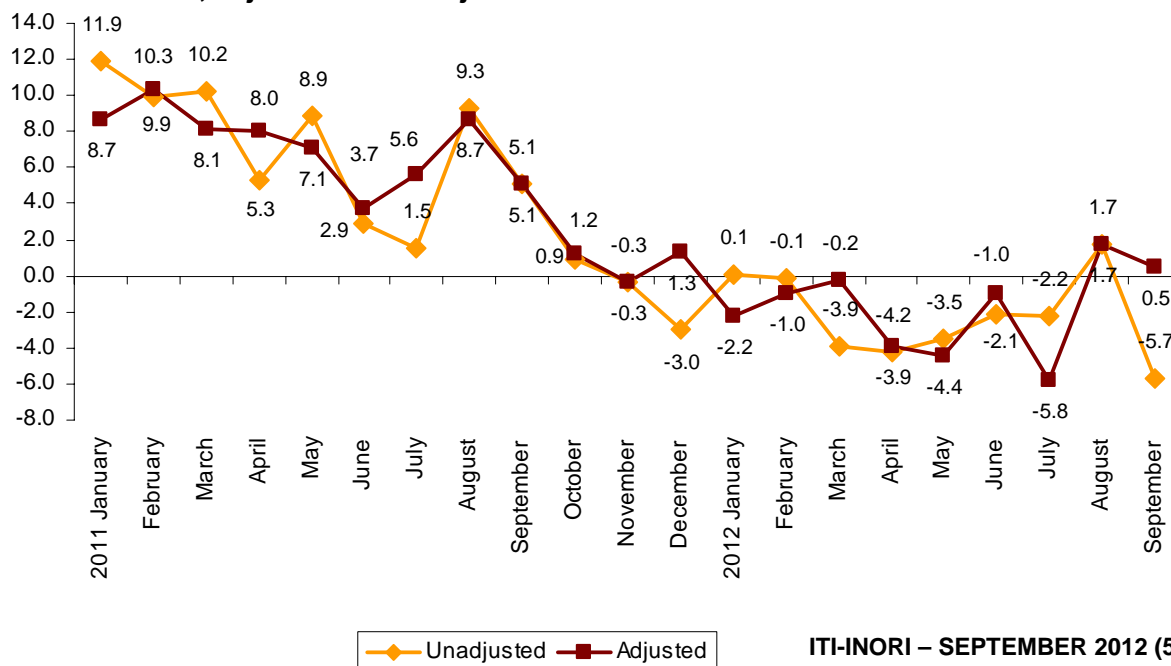
Annual and year-to-date average rates of INORI General index and by economic destination of the goods

After eliminating the calendar effect, that is, the difference between the number of working days in a given month in different years, **the interannual variation of the INORI in the month of September was 0.5%, more than half point lower than that registered in August.**
