### Industrial Turnover Indices (ITI). Base 2005 Industrial New Orders Received Indices (INORI). Base 2005

November 2011. Provisional data

### Main results

- The annual rate of the **Industrial Turnover Index** stands at **-1.7%** in the month of November, more than four points lower than that registered in October.
- By economic destination of the goods, all sectors register negative interannual rates, except Energy .
- The **variation of average** Turnover is **5.2%** in the first eleven months of 2011.
- The annual variation rate of **New Orders Received** in the month of October is **-0.5%**, more than one point lower than in October.
- The **average rate** of the General Industrial New Orders Received Index stands at **5.8%** in the first eleven months of 2011.

### **Evolution of Industrial Turnover**

The Industrial Turnover Index (ITI) experienced an interannual variation of the -1.7% in November, almost two points lower than that registered in October.

By economic destination of the goods, the industrial sectors that presented the greatest negative effects on the general index were:

- Intermediate goods, with an annual rate of -5.5% and an effect of -2.066 on the general index, due to the decreases registered in almost all activities comprising this sector. Among them, worth highlighting were Manufacture of other non-metallic products, Metallurgy; manufacture of iron, steel and ferro-alloy products and Manufacture of electrical material and equipment except household appliances. Nevertheless, worth noting was the increase in the Manufacture of grain mill products, starches and starch products and of prepared animal feeds.
- Capital goods, with an annual rate of -5.2% and an effect of -1.250, motivated by the drops in all activities comprising this sector. Among them, worth highlighting were Naval, railway, aircraft and spacecraft construction. Combat vehicles and Manufacture of metal products for construction, containers made of metal, steam generators, weapons and ammunition.

• **Durable consumer goods**, with an annual variation of **-20.8%** and an effect of **-0.596** on the general index, due to the negative evolution in all activities.

In turn, **Energy** was the only industrial sectors that presented a positive effect on the general index, with an annual variation of **28.1%** and an effect of **2.276** on the general index, motivated by the increase observed in the *Manufacture of coke and refined petroleum products*.

#### Details of the interannual variations

A more detailed analysis showed the activities that had the greatest effect on the annual rate of the ITI for the month of November.



### Year-to-date average rates

The average for the Industrial Production Index registered a variation rate of **5.2%** in the first eleven months of the year, as compared with the same period the previous year.

By economic destination of the goods, this rate was positive in Energy (33.9%), Intermediate goods (5.5%), Non-durable consumer goods (2.0%) and Capital goods (1.0%). In contrast, it was negative in Durable consumer goods (–13.6%).


## Annual rates and the average of ITI General index and by economic destination of the goods



### Evolution of the ITI, adjusted for the calendar effect

After eliminating the calendar effect, that is, the difference between the number of working days in a given month in different years, the interannual variation of the ITI in the month of November was –1.7%, more than two points lower than that registered in October.

#### **Evolution of Industrial New Orders Received**

The Industrial New Orders Received Index (INORI) experienced an interannual variation of **-0.5%** in November, more than one point below that registered in October.

By economic destination of the goods, the industrial sectors that presented the greatest negative effects on the general index were:

- Intermediate goods, with an annual variation of -5.2% and an effect of -2.003 on the general index, caused by the decreases in new orders received in almost all the activities comprising this sector. Among these, worth highlighting were *Manufacture of other non-metallic products, Metallurgy; manufacture of iron, steel and ferro-alloy products* and *Manufacture of electrical material and equipment except household appliances*
- Non-durable consumer goods, with an annual rate of -20.5% and an effect of -0.592 due to the negative evolution in new orders received in all activities.

In turn, the industrial sector with the greatest positive effect on the general index was:

• Energy, with an annual variation of 27.6% and an effect of 2.322 on the general index, mainly due to the increase registered in the *Manufacture of coke and refined petroleum products*.

### Details of the interannual variations

A more detailed analysis showed the activities that most affected the annual rate of the INORI in the month of November.



### Year-to-date average rates

The average rate of the General Industrial New Orders Received Index during the first eleven months of the year presented a variation of **5.8%**, as compared with the same period the previous year. By economic destination of the goods, this rate was positive in all industrial sectors, except in Durable consumer goods.


## Annual rates and the average of INORI General index and by economic destination of the goods
