Industrial Turnover Indices (ITI). Base 2005
Industrial New Orders Received Indices (INORI). Base 2005
December 2011. *Provisional data*

Main results

- The annual rate of the **Industrial Turnover Index** stands at **-4.0%** in the month of December, almost two-and-a-half points lower than that registered in November.
- By economic destination of the goods, **all sectors register negative interannual rates, except Energy**.
- **In the year 2011**, Industrial Turnover increases **4.5%**, as compared with 2010.
- The annual variation rate of **New Orders Received** in the month of December is **-3.4%**, three points lower than in November.
- The **average rate** of the General Industrial New Orders Received Index increases **5.0%** in 2011, as compared with the previous year.

Evolution of Industrial Turnover

The Industrial Turnover Index (ITI) experienced an interannual variation of the **-4.0%** in December, almost two-and-a-half points lower than that registered in November.

By economic destination of the goods, the industrial sectors that presented the greatest negative effects on the general index were:

- **Capital goods**, with an annual variation of **-12.0%** and an effect of **-3.006**, motivated by the drops in all activities comprising this sector. Among them, worth highlighting were *Manufacture of motor vehicles, trailers and semi-trailers* and *Naval, railway, aircraft and spacecraft construction. Combat vehicles*.
- **Intermediate goods**, with an annual rate of **-6.0%** and an effect of **-2.031**, due to the decreases registered in almost all activities comprising this sector. Among them, worth highlighting were *Metallurgy; manufacture of iron, steel and ferro-alloy products* and *Manufacture of other non-metallic products*.

• **Durable consumer goods**, with an annual rate of **-16.8%** and an effect of **-0.451** on the general index, due to the negative evolution in all activities.

In turn, **Energy** was the only industrial sectors that presented a positive effect on the general index, with an annual variation of **16.5%** and an effect of **1.599**, mainly due to the increase observed in the *Manufacture of coke and refined petroleum products*.

Details of the interannual variations

A more detailed analysis showed the activities that had the greatest effect on the annual rate of the ITI for the month of December.

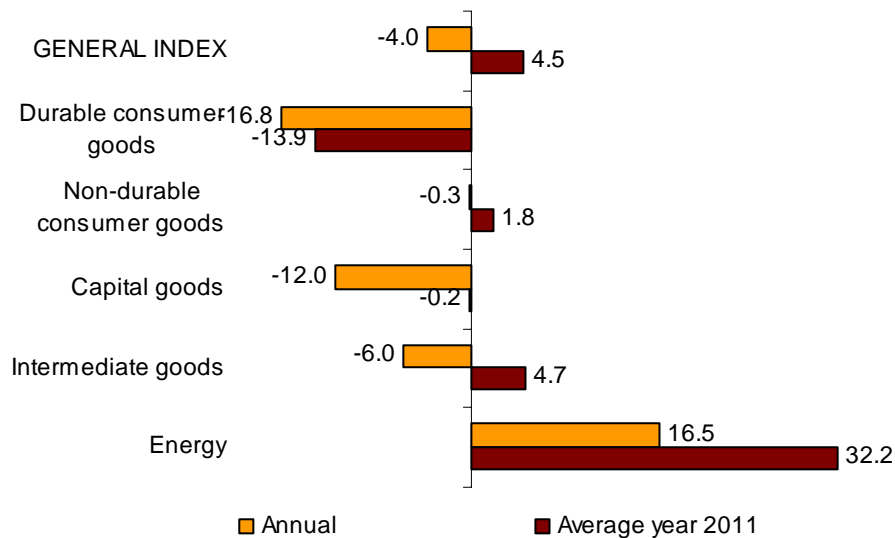

Year-to-date average rates

The average for the Industrial Production Index registered a variation rate of **4.5%** in 2011, as compared with the previous year.

By economic destination of the goods in 2011, this rate was positive in Energy (32.2%), Intermediate goods (4.7%) and Non-durable consumer goods (1.8%). In contrast, it was negative in Capital goods (-0.2%) and Durable consumer goods (-13.9%).

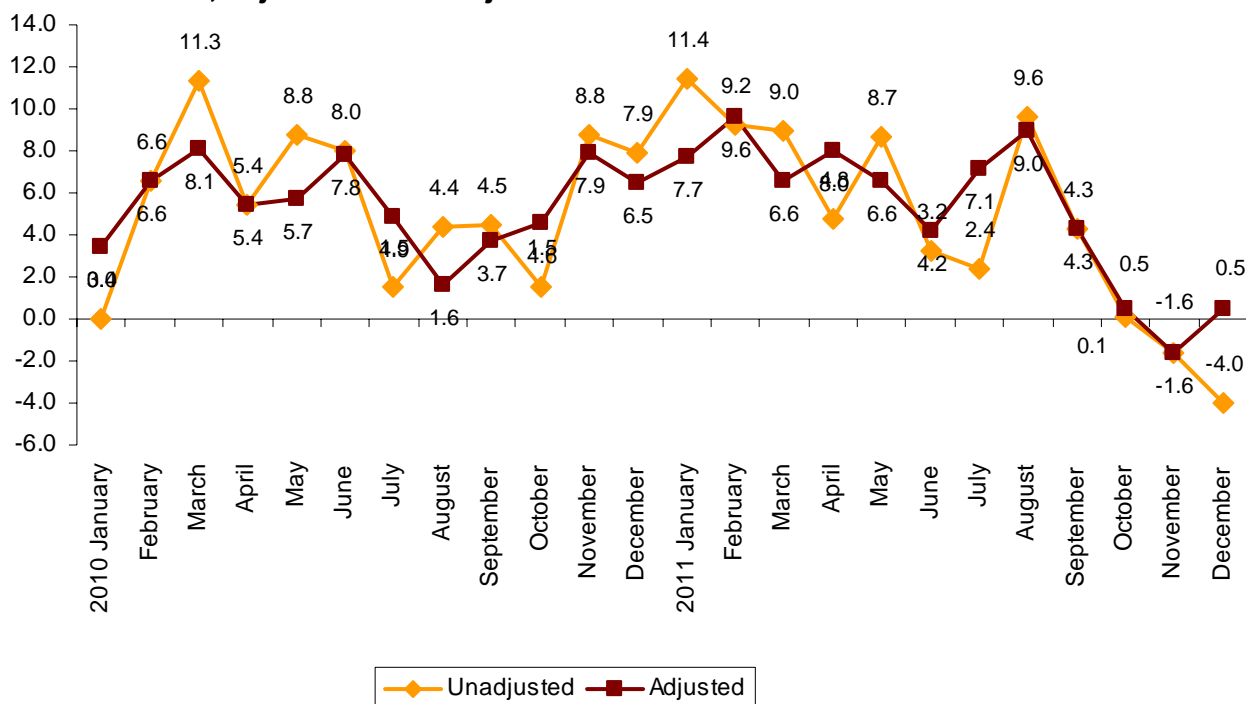
Annual rates and the average of ITI General index and by economic destination of the goods



Evolution of the ITI, adjusted for the calendar effect

After eliminating the calendar effect, that is, the difference between the number of working days in a given month in different years, the interannual variation of the ITI in the month of December was -0.5%, more than two points higher than that registered in November.

Evolution of Industrial New Orders Received

The Industrial New Orders Received Index (INORI) experienced an interannual variation of **-3.4%** in December, three points below that registered in November.

By economic destination of the goods, the industrial sectors that presented the greatest negative effects on the general index were:

- **Capital goods**, with an annual variation of **-9.2%** and an effect of **-2.103** on the general index, mainly due to the decrease registered in *Naval, railway, aircraft and spacecraft construction. Combat vehicles* and in the *Manufacture of motor vehicles, trailers and semi-trailers*. Nonetheless, within this sector, worth noting was the increase in the *Manufacture of machinery and equipment n.e.c.*.
- **Intermediate goods**, with an annual variation of **-5.1%** and an effect of **-1.775** on the general index, caused by the decreases in new orders received in almost all the activities comprising this sector, worth highlighting was *Manufacture of electrical material and equipment except household appliances*. Among the increases, the most influential was *Chemical industry except cleaning articles, perfumes and cosmetics*.

In turn, the industrial sector with the greatest positive effect on the general index was:

- **Energy**, with an annual variation of **15.8%** and an effect of **1.563** on the general index, mainly due to the increase registered in the *Manufacture of coke and refined petroleum products*.

Details of the interannual variations

A more detailed analysis showed the activities that most affected the annual rate of the INORI in the month of December.

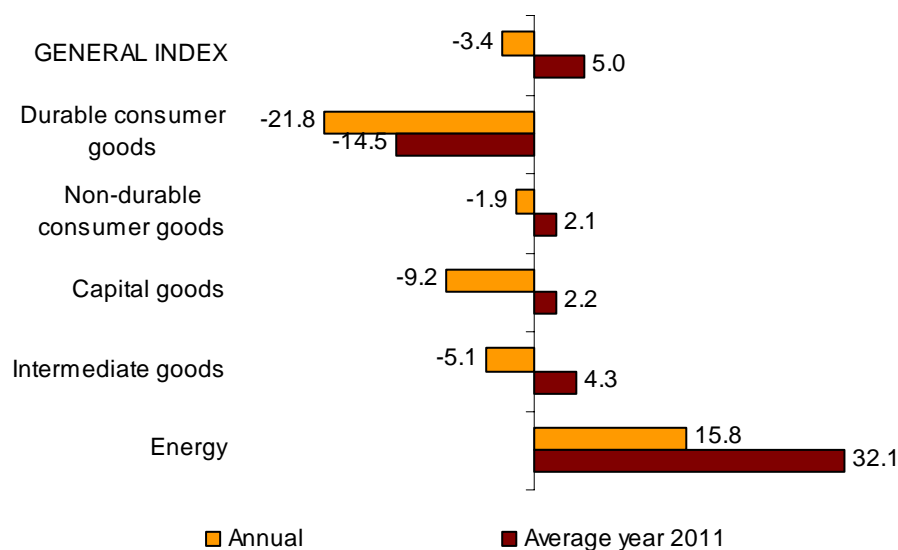

Year-to-date average rates

The average rate of the General Industrial New Orders Received Index in 2011 presented a variation of **5.0%**, as compared with the previous year. By economic destination of the goods, this rate was positive in all industrial sectors, except in Durable consumer goods.

General index and by economic destination of the goods

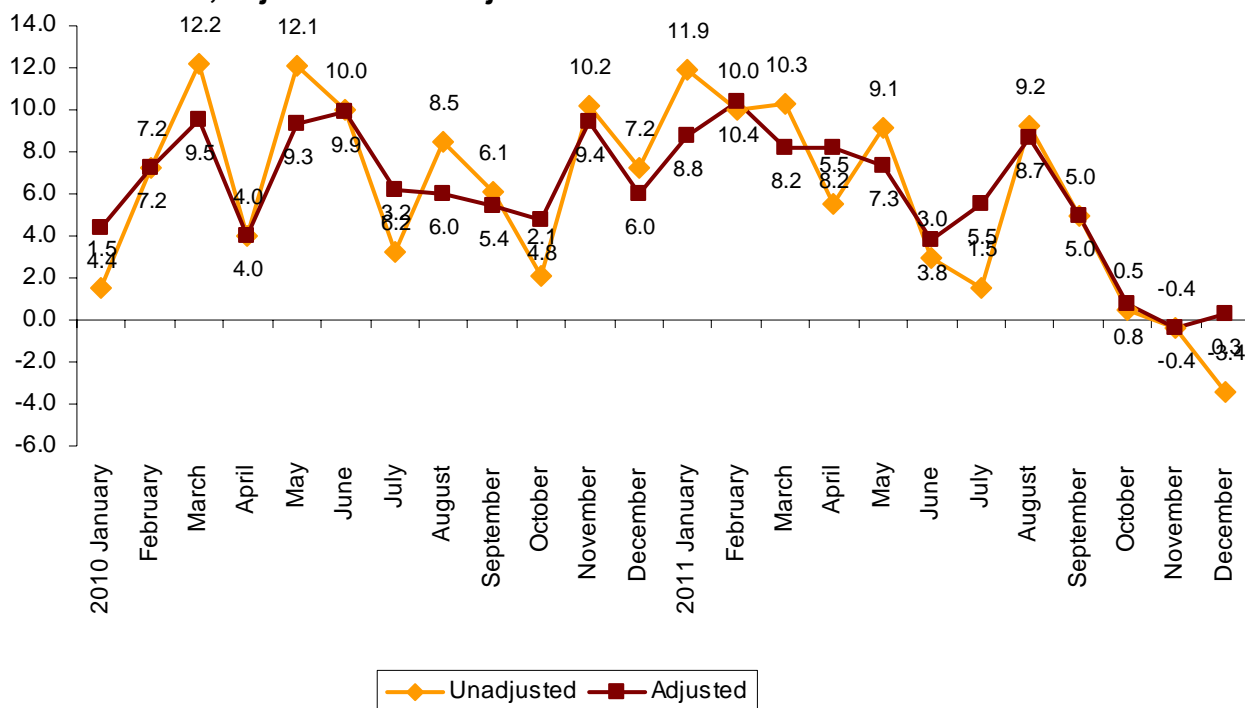


Evolution of the INORI, adjusted for the calendar effect

After eliminating the calendar effect, that is, the difference between the number of working days in a given month in different years, the interannual variation of the INORI in the month of December was 0.3%, seven tenths higher than that registered in November.
