**Export and Import Price Indices of Industrial Products.  
2005 Base.  
April 2008. Provisional data**

**The General Export Price Index interannual rate increases 2.7%**

**Import prices increase 6.6%**

The General Export Price Index increased 2.7% in April 2008 with regard to the same month from the previous year.

By economic destination of the goods, the variation rates with regard to the same month from the previous year stood at 2.2% for consumer goods (0.4% for durable consumer goods and 2.5% for non-durable consumer goods), -0.4% for capital goods, 1.0% for intermediate goods and 41.1% for energy.

In terms of monthly variation, the General Export Price Index registered a 0.3% increase in April, as compared with the month of March 2008.

Considering classification by economic destination of the goods, the variation rates in comparison with the previous month were 0.1% for consumer goods (0.2% for durable consumer goods and 0.2% for non-durable consumer goods), -0.1% for capital goods, 0.4% for intermediate goods and 2.6% for energy.

**The General Import Price Index increases 6.6% in April**

The General Import Price Index increased 6.6% in April 2008, as compared with the same month from the previous year.

By economic destination of the goods, the variation rates in comparison with the same month from the previous year were 0.5% for consumer goods (-3.3% for durable consumer goods and 1.7% for non-durable consumer goods), -0.1% for capital goods, 2.5% for intermediate goods and 36.7% for energy.

Regarding monthly variation, the General Import Price Index increased 1.2% in April with respect to March 2008.

Considering classification by economic destination of the goods, the variation rates with regard to the previous month were -0.3% for consumer goods (-0.3% for durable consumer goods and -0.2% for non-durable consumer goods), 1.0% for intermediate goods and 4.7% for energy. Capital goods did not show any variation.
