# Export Price Index (IPRIX) and Import Price Index (IPRIM) of Industrial Products. Base 2015

May 2023. Provisional data

The annual variation rate of the IPRIX stands at -1.9%, more than two and a half percentage points lower than that recorded in April

# The annual variation rate of the IPRIM is -4.9%, more than one percentage point lower than for the previous month

#### Annual evolution of export prices

The annual variation rate of the Export Price Index (IPRIX) was -1.9% in May, more than one and a half points below that for April.


Among the industrial sectors with a negative influence on the evolution of the annual rate of the General IPRIX, by the economic destination of the goods, worth noting were:

- Intermediate goods had a rate of -3.8%, more than two and a half points below that of April. Noteworthy in this evolution is the decrease in the prices of the *Manufacture of basic chemicals, fertilisers and nitrogen compounds, plastics and synthetic rubber in primary forms,* which increased in May 2022, and that the prices of the *Manufacture of basic iron, steel and ferroalloy products* rose less this month than in May of the previous year.
- **Energy**, which presents an annual variation of -42.5%, more than five points lower than in the previous month, as a result of the drop in *Refined petroleum products* prices, compared to the increase in the same month last year.
- **Non-durable consumer goods**, whose annual rate of 6.7%, one point below that of April, is due to the prices of the *Manufacture of other food products* falling, while they increased in relation to May of last year.

In turn, the only industrial sector with a positive influence was:

• **Consumer durable goods**, which increased its variation by two points to 7.8%, due to the increase in the prices of the *Manufacture of household appliances*, higher than that of May 2022.

#### Contribution of industrial sectors to the annual IPRIX rate





The annual variation of the overall index excluding Energy decreased nearly one and a half points, to 1.6%, standing more than three points above the overall IPRIX.

General index and general index without Energy. Percentage




#### Monthly evolution of export prices

In May, industrial export prices registered a monthly rate of -0.6%, as compared to the month of April.

By economic destination of the goods, among the industrial sectors that have a negative monthly effect on the general index, worth noting are:

- **Energy**, with a monthly variation of -6.4% and a contribution of -0.352, due to the decrease in the prices of the *Electric power generation, transmission and distribution* and, to a lesser extent, of *Refined petroleum products*.
- Intermediate goods, with a monthly variation of -0.9% and a contribution of -0.342, due to decreases in the prices of the *Manufacture of basic precious and other non-ferrous metals* and the *Manufacture of basic chemicals, fertilisers and nitrogen compounds, plastics and synthetic rubber in primary forms*.

On the other hand, worth noting amongst the sectors with a positive monthly effect was:

• **Capital goods**, with a variation rate of 0.2%; mainly as a result of the increase in prices of the *Manufacture of motor vehicles*. This sector's contribution to the overall index was 0.073.

A more detailed analysis showed the activities that most affected the monthly rate of the IPRIX in the month of May.


#### Annual evolution of industrial prices, combining domestic and foreign markets

The Industrial Price Index of the domestic and foreign markets, which is obtained through aggregating the IPRI and the IPRIX, fell in its annual rate by more than two points in May, to -5.0%.

In turn, the annual variation rate of the general index, excluding Energy, fell by nearly one and a half points, to 2.4%, standing more than seven and a half points above the general IPRI+IPRIX rate.

General index and general index without Energy. Percentage




#### Annual evolution of import prices

The Import Price Index (IPRIM) registered an annual rate of -4.9% in May, more than one point lower than that of April.

By economic destination, all industrial sectors had a negative influence on the variation of the annual IPRIM rate. Among these, worth noting were:

- **Intermediate goods**, which decreased its rate by more than one and a half points to -3.0%, due to the drop in prices of *Metallurgy; manufacture of iron, steel and ferro-alloy products* and the *Chemical industry*, compared to the rise in May last year.
- **Non-durable consumer goods**, with an annual rate of 1.2%, almost two points below that of April, as a result of the fact that the prices of the *Food industry* decreased this month, where they had increased in the same month of the previous year.
- **Energy**, whose variation decreased by nearly two and a half points to stand at -28.4%. The decrease in the prices of *Manufacture of coke and refined petroleum products*, which had increased in May 2022, stands out in this evolution.

#### Contribution of industrial sectors to the annual IPRIM rate




**Annual rate difference General IPRIM** 

The annual variation rate of the overall index excluding Energy decreased nearly one and a half points to 1.1%, standing nearly six points above the overall IPRIM.

General index and general index without Energy. Percentage




#### Monthly evolution of import prices

In May, the monthly variation of the Import Price Index was -1.5%.

By economic destination of the goods, among the industrial sectors that had a negative monthly effect on the general IPRIM, worth noting are:

- **Energy**, whose variation of -7.5% is due to the decrease in the prices of *Extraction of crude* petroleum and natural gas and, to a lesser extent, of *Manufacture of coke and refined* petroleum products. This sector's contribution to the overall IPRIM was -1.227.
- **Intermediate goods**, with a rate of –0.7% and a contribution of -0.206, due to the decrease in prices of the *Extraction of metallic minerals* and *Metallurgy; manufacture of iron, steel and ferro-alloy products*.

On the other hand, the only industrial sector with a positive influence was:

• **Capital goods**, with a variation rate of 0.1% and a contribution of 0.021, due to the increase in the prices of *Manufacture of machinery and equipment n.e.c.*

#### **Data Review and Update**

Coinciding with today's publication, the INE has updated the data of the IPRIX and IPRIM series corresponding to the last three months, becoming final in the month of February 2023. The results are available at INEBase.

#### Methodological note

The Export Price Index (IPRIX) is a short-term indicator that measures the monthly evolution of the prices of industrial products manufactured in the domestic market and sold in the foreign market.

On the other hand, the Import Price Index (IPRIM) is a short-term indicator that measures the monthly evolution of the prices of industrial products from the rest of the world.

In order to obtain them, a continuous monthly survey is conducted, which every month investigates industrial establishments that carry out operations in the foreign market.

**Type of survey**: monthly continuous survey.

Base year: 2015.

Reference period of the weightings: the year preceding the current year.

Population scope: industrial workplaces.

Sample size: 3,800 industrial establishments for the IPRIX and 4,700 for the IPRIM.

**Number of observations:** In the IPRIX approximately 14,000 monthly prices of 1,700 products and in the IPRIM approximately 18,000 prices of 2,100 products.

General calculation method: Laspeyres' Chain Index.

Collection method: internet (IRIA system), e-mail, fax, telephone or postal mail.
