Export (IPRIX) and Import (IPRIM) Price Indices of Industrial Products. Base 2015 July 2018. Provisional data

The annual variation rate of the IPRIX stands at 2.1%, the same than that registered in June

The annual variation rate of the IPRIM is 6.1%, more than one percentage point higher than that registered the previous month

Annual evolution of export prices

The annual rate of the Export Price Index (IPRIX) in July was **2.1%**, the same than that recorded the previous month.

By economic destination of the goods, the industrial sectors with the greatest positive influence on the stability in the annual rate of the IPRIX were:

• *Energy*, with a variation rate of **24.2%**, almost three points higher than in June, due to the increase in the prices of *Electric power generation, transmission and distribution*, compared to the decrease registered in 2017.

It is noteworthy, although in the opposite direction, the decrease in the prices of *Manufacture of refined petroleum products*, which increased last year.

• *Capital goods*, whose annual variation increased one tenth of a point, up to -0.1%, mainly due to the fact that the prices of *Manufacture of motor vehicles* fell this month less than they did in 2017.


On the other hand, amongst the industrial sectors with a negative influence, worth noting were:

• **Intermediate goods**, with a variation rate of **3.2%**, three tenths of a point lower than that of June, mainly due to the decrease in the prices of *Manufacture of basic precious and other non-ferrous metals*, which increased last year.


It is also important to highlight, although in the opposite direction, the stability registered in the prices of *Manufacture of basic chemicals, fertilisers and nitrogen compounds, plastics and synthetic rubber in primary forms*, compared to the decrease in July 2017.

The annual variation rate of the **general index excluding** *Energy* decreased one tenth of a point, to **1.1%**, standing nearly one point below that of the general IPRIX.




IPRIX-IPRIM – JULY 2018 (2/12)



Monthly evolution of export prices

In July, industrial export prices registered a monthly rate of **-0.2%** as compared to the month of June.



By economic destination of the goods, the sectors with the greatest negative monthly contribution to the general index were:

• *Intermediate goods*, with a monthly variation rate of -0.7%, and a contribution of -0,244, mainly due to the decrease in the prices of *Manufacture of basic precious and other non-ferrous metals.*

• *Capital goods*, with a variation rate of -0.1% and a contribution -0.025, due to the decrease in the prices of *Manufacture of motor vehicles*.

On the other hand, the only sector with a positive contribution to the general index was:

• *Energy*, whose variation rate stood at **1.9%**, due to the increase in the prices of *Electric power generation, transmission and distribution.* The contribution of this sector to the general index was **0.125**.

It is also worth noting, although in the opposite direction, the fall in the prices of *Manufacture of refined petroleum products*.

A more detailed analysis shows the activities that most contributed to the monthly rate of the IPRIX in the month of July.

Annual evolution of industrial prices, including domestic and foreign markets

The Industrial Price Index of the domestic and foreign markets, which is obtained as the aggregation of the IPRIM and the IPRIX, increased its annual rate by three tenths in July, up to **3.8%**.

On the other hand, the annual variation rate of the **general index excluding** *Energy* remained at **1.2%**, standing more than two points below the general IPRIM+IPRIX.

Annual evolution of import prices



The Import Price Index (IPRIM) registered an annual rate of **6.1%** in July, more than one point above that of the previous month.

By economic destination of the goods, all industrial sectors had a positive contribution to this development. Among them, worth noting were:


• **Energy**, with an annual variation rate of **28.4%**, more than three and a half points higher than that of the previous month, due to the increase in the prices of *Extraction of crude petroleum and natural gas* and, to a lesser extent, of *Manufacture of coke and refined petroleum products*, which were higher this month than last year.

• **Intermediate goods**, which showed a variation rate of **3.4%**, more than one percentage point higher than that registered in July, due to the increase in the prices of *Chemicals and chemical products* and of *Manufacture of basic metals*, compared to the decreases registered in 2017.



Influencia de los sectores industriales en la tasa anual del IPRIM


The annual variation rate of the **general index excluding** *Energy* increased six tenths up to **1.1%**, standing five points below the general IPRIM.

In July, the monthly variation of the Import Price Index was 0.7%.

By economic destination of the goods, the industrial sectors that had a positive monthly contribution to the general index were:

• *Energy*, with a monthly variation of **3.4%** and a contribution of **0.669**, due to the increase in the prices of *Extraction of crude petroleum and natural gas* and, to a lesser extent, of *Manufacture of coke and refined petroleum products*.

• *Intermediate goods,* with a variation rate of **0.4%** and a contribution of **0.109**. Worth noting in this evolution was the increase in the prices of *Mining of metal ores*.

A more detailed analysis showed the activities that most affected the monthly rate of the IPRIM in the month of July.
