### Services Sector Price Index (SSPI). Base 2015 Second Quarter 2023. Provisional data

# Sea and coastal freight water transport prices registered an annual rate of 0.5%, almost five points below that of the previous quarter

# The annual rate of *Information service activities* increased by more than one point to stand at 3.7%

### Annual evolution of the prices of services

In the second quarter of 2023 the annual variation in the prices of services decreased in 10 of the 15 activities for which indices are calculated, increased in four and remained stable in the rest.

The activities whose annual rate registered the greatest decreases compared with the first quarter of 2023 were:

• **Passenger air transport**, with a variation of 0.5%, almost five and a half points below the figure of the previous quarter, due to the fact that the prices of this activity increased less than in the second quarter of last year.

• *Advertising*, with an annual rate of 5.2%, five points below that of the previous quarter. This development is a consequence of the price increase of this activity this quarter being less than that of 2022.


In turn, among the activities whose annual rate increased with respect to the previous quarter, those worth highlighting are:

• **Information services**, whose variation rose by more than one point, to 3.7%. This behaviour was caused by the fall in prices for this activity, in contrast with the decrease recorded for the second quarter of the previous year.

• *Warehousing and storage,* whose rate stood at 4,7%, seven tenths above the figure for the first quarter, due to the rise in prices for this activity, greater than that of the second quarter of 2022.

The greatest price increases in the second quarter of 2023 as compared to the first occurred in *Advertising* (9.7%), *Passenger air transport* (6.9%) and *Goods Handling* (1.2%).



On the other hand, the greatest decreases occurred in *Sea and Coastal freight water transport* (-0.7%) and *Postal and courier activities* (-0.3%) and *Telecommunications* (-0.3%).

#### Data Review and Update

Coinciding with today's publication, the INE has updated the SSPI series data for the last four quarters, with the second quarter of 2022 becoming final. The results are available at INEBase.

## Methodological note

The Services Sector Price Indices (SSPI), which are published on a quarterly basis, aim to measure the evolution of the prices of services provided by companies operating in the services sector in Spain, from the supply side (producer's point of view). The prices considered for the calculation are those of the services provided to companies (business segment).

The sectors for which the SSPI are calculated are those included in Regulation (EC) No. 1158/2005 of the European Parliament and of the Council of 6 July 2005 concerning short-term statistics.

Type of survey: quarterly continuous survey.

Base year: 2015.

Reference period of the weightings: the year preceding the current year.

Population scope: services companies.

Sample size: around 850 companies and 111 products.

Number of observations: approximately 7,000 quarterly prices.

General calculation method: Laspeyres' Chain Index.

**Collection method**: internet (IRIA system), e-mail, fax, telephone or postal mail.
