Services Sector Price Indices (SSPI). Base 2006 Third quarter of 2012. *Provisional data* 

# The greatest price decreases in the annual rate is produced in *Telecommunications*, with 3.2 points, up to –7.6%

The rate of the services of *Advertising and market studies* stands at –6.5%, registering an increase of 4.0%

### Annual evolution of prices in services

Ten of the 14 activities in the services sector for which price indices are calculated, experienced a decrease in their interannual variation rate in the third quarter of 2012.

Among the services with a decrease in annual rate, the most noteworthy were:

• **Telecommunications**, that decrease its annual variation more than three points, up to -7.6%. This drop was due to that the prices of this activity increased this quarter less than in the period of the previous year.

• **Sea freight transport**, with an annual rate of 3.0%, more than one-and-a-half points lower than that registered in the second quarter, due to the decrease in prices of these services, that increased in 2011.

• **Scheduled passenger air transport**, whose annual variation stood at 3.2%, more than one point lower than the previous quarter. This behaviour was due to that the rise in prices of this activity in the third quarter was lower than the previous month.


In turn, among the services with an increase in annual rate, worth noting:

• Advertising and market studies, with an annual rate of -6.5%, four points higher than that registered the previous quarter. This increase was due to that this quarter the prices of this activity decreased less than in the third quarter of 2011.

• **Information services**, whose annual variation increased more than one-and-a-half points, up to -0.2%, due to its prices increased this quarter, as compared with the decrease showed in the same period of the previous quarter.

• *IT activities,* that increased its rate five tenths, standing at 1.4%, due to the increase in prices, that remained stable in the third quarter previous year.



#### Quarterly evolution of the prices of services


The greatest price decreases as compared with the second quarter of 2012 were recorded in *Advertising and market studies* (–17.8%) and *Postal and courier activities* (–1.3%).

Conversely, among the activities that increased their prices this quarter as compared with the previous quarter, worth noting *Scheduled passenger air transport* (2.4%), *Information services* (0.9%) and *IT activities* (0.5%).
