Services Sector Price Index (SSPI). Base 2015 Third quarter 2023. Provisional data

Air passenger transport prices registered an annual rate of -2.3%, almost three points lower than in the previous quarter

The annual rate of *Telecommunications* rose by almost two and a half points and stands at 3.0%

Annual evolution of the prices of services

In the third quarter of 2023 the annual variation in the prices of services decreases in eight of the 15 activities for which indices are calculated, increases in 5 and remains stable in the remaining two.

The activities whose annual rate registers the largest decreases compared to the second quarter of 2023 are:


- **Passenger air transport**, whose rate stood at -2.3%, almost three points lower than in the second quarter, as a result of the fact that the increase in prices for this activity was lower than in the third quarter of the previous year.
- *Maritime cargo transport*, whose annual variation of -1.5%, more than two and a half points lower than in the previous quarter, is due to the fall in its prices, compared with the increase recorded in the same quarter of 2022.

In turn, among the activities whose annual rate increased with respect to the previous quarter, those worth highlighting are:

- **Telecommunications**, with an annual rate of 3.0%, almost two and a half points higher than in the second quarter. This evolution is due to the rise in the prices of this activity, which is higher than in the third quarter of last year.
- *Advertising*, which increased by more than one and a half percentage points to 6.8%, as prices fell less in this quarter than in the third quarter of 2022.

CNAE Activities. Percentage




Quarterly evolution of the prices of services

The greatest price increases in the third quarter of 2023 as compared to the second quarter are in *Telecommunications* (2.8%) and *Passenger Air Transport* (0.4%).

On the other hand, the greatest decreases occurred in *Advertising* (-17.4%) and *Postal and Courier Activities* (-0.4%).

Data Review and Update

Coinciding with today's publication, INE has updated the IPS series data for the last four quarters, with the third quarter of 2022 becoming final. The results are available at INEBase.

Methodological note

The Services Sector Price Indices (SSPI), which are published on a quarterly basis, aim to measure the evolution of the prices of services provided by companies operating in the services sector in Spain, from the supply side (producer's point of view). The prices considered for the calculation are those of the services provided to companies (business segment).

The sectors for which the SSPI are calculated are those included in Regulation (EC) No. 1158/2005 of the European Parliament and of the Council of 6 July 2005 concerning short-term statistics.

Type of survey: quarterly continuous survey.

Base year: 2015.

Reference period of the weightings: the year preceding the current year.

Population scope: services companies.

Sample size: around 850 companies and 111 products.

Number of observations: approximately 7,000 quarterly prices.

General calculation method: Laspeyres' Chain Index.

Collection method: internet (IRIA system), e-mail, fax, telephone or postal mail.
