Report of the activity of the School of Statistics of the Public Administrations (EEAP) in the year 2016

The EEAP deals with specific training in official statistics and disciplines related to statistical production by organising courses and seminars directed not only to INE staff but also to the entire Public Administration and other groups that require it.

The School's training activities include face-to-face courses and seminars, online courses, technical sessions, "educational" visits to schools, universities and other tailor-made training sessions.

It is also in charge of the collaboration programme with various universities to carry out internships in the Organisation, as well as the follow-up of the scholars included in the INE Training Scholarship plan.

1. Face-to-face courses

During 2016 the EEAP organised a total of 26 face-to-face courses and seminars. The average duration was 8 hours for courses and 4 hours for seminars. Three main types of courses are considered: those on official statistical production, those on statistical specialization and those on statistical computing. The courses in the first group deal with statistical operations, innovations, methodological changes, or aspects related to the correct use, application, interpretation and analysis of the data. The second group has an advanced scientific content on methodological and statistical techniques and the third group includes courses on statistical programmes to support production. Appendix I lists all EEAP face-to-face courses taught during 2016, as well as the number of teaching hours and students attending such courses.

The training plan in computer science, especially in SAS, started in 2011 has been continued, although the number of seminars has already been reduced

considerably. On the other hand, in 2016 two internal Excel seminars on tables and dynamic graphs were carried, when this training requirement was observed.

2. "Online" courses on the IEF platform.

The online courses programme started in 2013, in order to allow the training to reach groups that can not attend the face-to-face activities, thanks to the collaboration and funding of the Institute of Fiscal Studies (IEF).

3. "Online" courses aimed towards Latin America on the CEDDET platform

Within the International Cooperation programmes there is online training in statistics directed primarily at the Latin American context.

During 2016 three new courses were included on: Basic demographic Indicators, Social statistics: health, disability, education, justice and other social issues and Spanish National Accounts (base 2010), and three specialised workshops on: Sample design of economic surveys, Life quality indicators and User-oriented statistical communication.

4. Technical sessions

In addition to the previous courses and seminars, a series of Technical Sessions was offered among the School's activities, with the objective of offering statisticians related to the Official Statistical System a forum for contact and debate on topics of interest in the field of official statistics. 11 Technical Sessions were held in 2016.

The Provincial Delegations of INE were sent the recordings of these sessions on DVD. As of 2016, these recordings are available on the INE intranet for all staff.

5. Informational seminars and Educational visits

This year, on the occasion of the publication of the selective processes for the Statistical Bodies, two informative seminars were held on them, attended by a total of 165 people. The objective of these seminars is to offer a general overview of the opposition Programmes. As well as providing information about the work carried out by officials of the State Statistical Bodies in the INE.

Central Services received educational visits from five universities: Universidad Europea de Madrid, UNI Cardenal Cisneros, Universidad Autónoma de Madrid, UCM (Universidad Complutense de Madrid) and Miguel Hernández University and 18 Institutes of Secondary Education throughout the academic year 2015-2016.

The Provincial Delegations play a very important role in collaboration with the General Subdirectorate of Statistical Dissemination, by carrying out the *Educational Visits Plan*. During the academic year 2015-2016 the number of educational visits reached 81. This quantity is lower than in the previous year as in this period various electoral processes were carried out which impeded educational visits to the Provincial Delegations.

6. University Internship Programme

The objective of the university internship programme is to promote the incorporation of interns in the field of public administration and private companies, promoting the employability of future professionals, fostering their capacity for entrepreneurship, creativity and innovation and responding to their commitment to economic transformation based on the society of knowledge.

The INE considers that training in statistics is important for preparing future producers and users of statistics, so it is beneficial for this Organisation to use any means to promote knowledge, by signing Collaboration Agreements with the Universities that have requested it so that their students can carry out internships at the INE. Currently 28 agreements have been signed.

During the academic year 2015-2016, 23 students were received, of which 7 were at Provincial Delegations and 16 at Central Services.

7. INE Training Scholarships

The National Institute of Statistics has a grant programme, through direct scholarship grants, to promote and encourage statistical research as well as the development and implementation of statistical processes through postgraduate training.

The experience accumulated in recent years has shown that the awarding of scholarships represents, for the National Institute of Statistics, a source of knowledge of excellent professionals who, after overcoming the opportune oppositions, may end up being integrated into the organization itself.

During 2016, 9 scholarships continued from the 2015 offer until the end of the current scholarship period and 15 new scholarships were incorporated, 9 of which are currently continuing within the Organisation.

In 2016, six specific training sessions were held with this group at the EEAP.
