#### Central Business Register (CBR) as at 1 January 2022

# The number of active enterprises increased 1.9% during 2021 and stood at 3.43 million

# 18.4% of active enterprises were 20 or more years old and 17.4% were less than two years

As of January 1, 2022, there were 3,430,663 active companies in Spain, 1.9% more than on the same date the previous year, according to data from the Central Business Register (CBR).

The *Rest of the Services sector*, once again had the highest weight in the structure of the population of companies. On 01 January 2022, it represented 61.2% of the total.

This sector, which had 2,098,974 active enterprises, includes all those dedicated to hospitality, transportation and storage, information and communications, financial and insurance activities, real estate, professional, scientific and technical activities, administrative activities and auxiliary services, educational, health and social assistance and other social activities, including personal services.

The weight of *Trade* was also significant, with 20.8% of the total. This sector includes companies which carry out wholesale trade, retail trade and commission trade.

Finally, Construction sector companies represented 12.4% of the total ad Industrial sector companies 5.6%.

#### Active companies by number of employees

1.94 million enterprises did not employ any employees at all at January 1, 2022. This figure represented 56.6% of the total. Besides this, 905,804 companies (26.4% of the total) had one or two employees. If these two groups are added together, 83% had two or less employees.

Considering only the companies with employees, those that had 20 or more employees represented 4.6% of the total.

The highest percentage of small companies occurred in the *Rest of the Services* sector (85.3% hadtwo or less employees). In turn, the weight of large companies was concentrated in the *Industrial* sector, where 8.4% of the total employed 20 or more workers.

#### Active companies by age

Only 18.4% of the actives companies existed 20 or more years ago.

On the contrary, as a matter of fact, 17.4% had less than two years as economically active units.

Company age distribution shows significant variations according to the different activity sectors considered. Thus, industrial companies have the highest proportions of veteran companies (30.8% are 20 years old or over).

More young companies are represented in activities related to the *Services* sector, especially in *Hospitality* (19.4% have not yet completed their second year of existence) and *Construction* (18.4%).

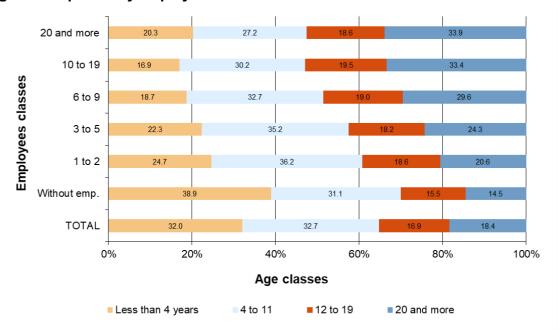
#### Active companies by size and age ranges

Distribution by age is linked to company size. Thus, the presence of very young companies was highly relevant as of January 1, 2022 in the microenterprise segment (38.9% of companies without employees were between their first and fourth years of life).

On the other hand, there was a greater representation of older companies in the larger ones (33.9% of companies with 20 or more employees were at least 20 years old).

The following graph combines the age of the companies with other basic structural element, such as the size measured in function of its stratum of employees.

## Active companies that have a natural person as legal foundation, by sex

The CBR registered 1,912,800 companies with a natural person as legal foundation at the 1<sup>st</sup> of January 2022. This population represented 55.8% of the total set of units.

From the total for these companies, 36.9% had a woman as the natural person. It should be noted that the representation level is not homogeneous for all economic activities, however. Activities related to *Education*, *Health and Social Services* sectors have a majority presence of businesswomen (56.8%).

In the *Retail trade* and Other services sectors, the presence of women was also notable, with 46.1% and 44.1% of the total, respectively.

On the other hand, men were the majority presence in *Construction* (97.0% of the total) and *Transportation and Storage* (90.1%) activities.

## Company registrations and de-registrations

According to the evolution over the past year, 382,960 companies began the exercise of economic activities during 2021. On the other hand, 316,340 ceased all their activities.

81.3% of the units registered as at 01 January 2022 were already active in the same date of the previous year.

Regarding the sectors with the highest negative balances, these were *Postal and courier activities* (–1,627) and *Legal and accounting activities* (–778).

# **Active companies by Autonomous Communities**

Cataluña was the Autonomous Community which concentrated the greatest number of active companies at 01 January 2022, with 18.5% of the total.

This was followed by Comunidad de Madrid (16.3%) and Andalucía (15.9%).

By Autonomous Communities, Cataluña concentrated 18.5% of total establishments and Andalucía and Comunidad de Madrid 15.9% each one.

# Methodological note

The new definition of company, implemented in the DIRCE system with reference to 2018, affects the aspects of organizational structure, autonomy of decision and market orientation. In short, the economic factors of the units prevail over the traditional vision, which is more oriented towards legal aspects. The data generated in the 2021 CCD reference cycle - recently published and the focus of this publication - are consistent with those of the three previous years and allow for the temporal comparison of aggregates.

The Central Business Register (CBR) gathers all Spanish companies and their local units located in the national territory in a single information system. It is a key infrastructure tool which enables the carrying out and coordination of the research system aimed at the productions units.

In order to meet this requirement, the CBR must be duly updated and the units must be shown with reliable identification, localization and classification data.

The CBR is compiled and maintained annually from data originating from diverse sources of a statistical and administrative nature. All this information is subjected to a sophisticated itinerary of cleaning, standardization and integration with the object of achieving total nationalcoverage. It is normally published in the first days of December, date which is conditioned by the periods where primary sources are available.

The CBR is a product implemented by the INE since 1989 and contains information relative to the population of companies in the national territory, as well as of the local units where these carry out their activities.

#### Other objectives are:

- Provide structural data on the number of companies and premises existing in Spain classified according to their main economic activity, employee ranges, legal status and geographic location.
- Provide data on the temporal evolution of companies in terms of new companies, existing companies and companies closed, found in the year the Directory was updated, and their classification by the usual variables.
- Satisfy the information demands required by international organizations, and in particular, bythe Statistical Office of the European Union (Eurostat).
