Elections to the Castilla y León Parliament on February 13, 2022

A total of 2,094,490 voters will be able to vote in the elections to the Courts of Castilla y León

The electoral roll may be consulted from December 27 to January 3

Voters residing abroad who wish to vote must apply by January 15

On February 13, 2022, 2,094,490 voters will be eligible to vote in the elections to the Courts of Castilla y León.

Of the voters living Castilla y León, 51,755 will be able to participate in these elections for the first time, due to having turned 18 since the last election for the Courts of Castilla y León, held on May 26, 2019.

Consultation of the electoral census and claims

The electoral roll of residents in Castilla y León can be consulted from December 27th to January 3rd in the town halls and in the provincial delegations of the Electoral Census Office (ECO). Votes resident abroad will be able to check their registration details at consular offices on these same dates.

Voters may present claims on their registration data in the city councils, consulates or in the provincial delegations of the ECO, within the same period, from December 27 to January 3.

The INE Electronic Headquarters (https://sede.ine.gob.es) also provides a service to verify registration data in the electoral roll and to check polling station site and address, upon accreditation of voter identity with a recognised electronic certificate.

Application to vote by electors residing abroad

Electors residing abroad who wish to vote must apply to the ECO Provincial Delegation corresponding to their municipal registration until January 15th. The ECO will send the official application form to those with the right to vote.

Applications can be submitted online. To do so, you must identify yourself using the Cl@ve system or use the password sent with the official form. You can also find your password online at the INE's electronic headquarters.

The form is also available at consulates and on the web pages of the convening administrations, the Ministry of Foreign Affairs, European Union and Cooperation and the INE (https://sede.ine.gob.es/votoCorreoCera?cierre=0000429).

Requests to opt out of receiving electoral propaganda

Voters may request their exclusion from the copies of the electoral roll that are provided to the representatives of the candidacies for the sending of electoral propaganda. These exclusions are continuous and have permanent effect unless the voter expresses otherwise.

Those who make this request until January 3rd will not receive electoral propaganda from the political parties in the election campaign of these elections. Requests received later than January 3rd will take effect in the following elections.

The request for exclusion can be made online, via accreditation by the Cl@ve system, at the INE Electronic Headquarters (https://sede.ine.gob.es/oposicionPartidos) or in the town halls, consular offices and provincial delegations of the OCE.

Census cards

Starting January 17th, the Electoral Census Office will send each elector residing in Castilla y León a roll card with information in the polling station and the polling place where they should vote.

On the INE website (http://www.ine.es), relevant information is available on the actions of the ECO in these elections, count of voters, claims, polling stations and electoral premises, postal voting, deadlines and legal regulations.

In addition to the consultation of the current electoral roll, the following procedures are offered at the Electronic Headquarters of the INE, without the need for accreditation with electronic certificate:

- General consultation of polling stations and electoral premises
- Consultation of the status of the postal vote and certified sending number, if it was sent through the Post Office
- Completion of the vote-by-mail application
- Consultation of electronic processing code (EPC) to request the Electoral Census of Absent Residents (ECAR) vote

In addition, the provincial delegations of the ECO deal with consultations on actions within their competence (registration in the census, polling stations and voting places, census cards, postal voting, etc.) and via the telephone number 900.343.232 (free) and 901.101.900.
