#### Statistics on Annulments, Separations and Divorces Year 2020


In 2020 there were 77,200 divorces, 15.8% less than in the previous year.

# Joint custody was granted in 41.4% of divorce and separation cases between spouses with children.

During 2020 there were a total of 80,015 cases of annulment - a decline of 16.1% compared to the previous year, for a rate of 1.7 per 1,000 inhabitants.

It should be noted that the greatest decreases in the annual rate in the number of annulments, separations and divorces were registered in the quarter where mobility was restricted by the pandemic, especially in the second quarter.

By type of resolution, 50,388 cases were settled by sentence and 29,627 by decree or public deed.

By type of process, there were 77,200 divorces, 2,775 separations and 40 annulments. Divorces accounted for 96.5% of the total, separations for 3.5% and annulments accounted for less than 0.1%.

The number of divorces decreased by 15.8% compared to the previous year, while separations decreased by 22.7% and annulments by 46.7%.

There were 1,095 same-sex divorces in 2020 (1.4% of the total). Among them, 545 were men and 551 were women. There were also four separations (0.1% of the total).

#### Divorces and separations by class

81.3% of divorces in 2020 were by mutual agreement, while the remaining 18.7% were contentious. In the case of separations, 89.0% were by mutual agreement and 11.0% contentious.

#### **Duration of Marriages**


The average duration of marriages up to the date of the resolution was 16.6 years, a number slightly lower than in 2019.

Marriages dissolved by divorce had an average duration of 16.3 years, while that of separated marriages was 22.5 years. Meanwhile, the average time elapsed between marriage and the declaration of annulment was 11.1 years.

32.8% of divorces occurred after 20 years of marriage or more, and 19.0% between five and nine years.

In the case of separations, 50.6% of marriages lasted 20 years or more and 14.9% between 15 and 19 years.

#### **Duration of proceedings**

69.6% of divorces were resolved in less than six months (compared with 76.0% in 2019). On the other hand, in 10.3% of cases, the duration was one year or more (compared with 8.0% in 2019).

79.0% of the separations were resolved in less than six months (82.6% in 2019), while 6.0% took a year or more (5.4% in 2019).


The average duration of proceedings was 5.4 months, slightly higher than in 2019. In separations, the average duration (4.2 months) was lower than in divorces (5.5 months).

According to the type of divorce and separation proceedings, the average duration of the mutually agreed proceedings was 3.9 months, while the average duration of the contentious proceedings stood at 12.0 months.

53.5% of mutual agreement procedures were resolved in less than three months and 27.9% in a period of three to five months.

On the other hand, 43.5% of contentious proceedings were resolved between six and 11 months, and 37.0% in 12 or more months.

#### Average age, nationality and marital status of the spouses

The largest number of divorces between spouses of different sex took place in the 40-49 age group, for both men and women.

In the separations, the highest number also occurred in the 40-49 year old age group.

The average age of the women was 45.8 years (45.6 years in divorces, 50.3 in separations and 42.9 in annulments). In the case of men, the average age was 48.2 years (48.0 years in the case of divorces, 52.8 years for separations and 49.2 years for annulments). These average ages were similar to those registered in 2019.

In 82.0% of the different sex divorces, both spouses were of Spanish nationality. In 10.6%, one of the spouses was a foreigner and in 7.4%, both spouses were foreigners.

Regarding the marital status of different sex spouses when they married, most were single. In the case of men, 8.2% were divorced and 0.5% widowed. Among the women, 8.9% were divorced and 0.5% were widows.

#### Number of children, custody and pensions


42.0% of the marriages corresponding to the separation or divorce resolutions did not have children (minors or economically dependent adults). This percentage was similar to that of the previous year.

46.0% had only minor children, 5.4% had only economically dependent adult children and 6.7% had economically dependent minor and adult children. 26.0% had only one child (minor or adult economically dependent).

Joint custody of minor children was granted in 53.0% of divorce and separation cases between different sex spouses. In 54.5% of cases custody was granted to the mother (58.1% in the previous year), in 3.9% the father obtained custody (4.1% in 2019), in 41.4% custody was shared (37.5% in 2019) and in 0.3% it was granted to other institutions or family members.

In divorces and separation of same sex spouses, in 24.4% of divorces and separations, custody measures were adopted in 24.4% of the cases. Of these, in 45.5% custody was obtained by one of the two spouses and in 53.4% it was shared.

In 58.5% of the cases of divorce and separation of different sex spouses, an alimony was assigned (57.1% in the previous year). In 61.4%, the alimony corresponded to the father (65.0% in 2019), in 3.8% to the mother (4.1% in the previous year) and in 34.8% to both spouses (30.9% in 2019).

On the other hand, in divorces and separations between same sex spouses, alimony was assigned in 24.9% of the cases.

In 8.5% of separations and divorces of different sex spouses, a compensatory pension was established. In 91.9% of these, payment was assigned to the husband.

As for who made the filing, in 71.6% of the cases of separation and divorce of different sex spouses it was presented by both spouses, in 18.3% by the wife and in 10.1% by the husband.

#### Results by Autonomous Communities and Cities<sup>1</sup>

The rate of annulments, separations and divorces per 1,000 inhabitants in Spain was 1.7 in 2020.

The autonomous city of Ceuta (2.1) recorded the highest rate per 1,000 inhabitants On the other hand, Aragón (1.3) presented the lowest.



#### **Data Review and Update**

The data published today is final and is not subject to further revision. All results are available on INEBase.

#### Methodological note

The Statistics on Annulments, Separations and Divorces are carried out by the National Institute of Statistics (INE) by virtue of the Agreement signed with the General Judicial Council (GJC) dated February 14, 1995, and updated through an addendum in 2006.

It is oriented to the study of matrimonial dissolution proceedings handled through sentences, decrees and public deeds on behalf of the judges, the judicial administration lawyers (formerly judicial secretaries) and notaries, respectively.

The objective of this statistic is to determine the number of these sentences, decrees and public deeds by providing information on some of the main socio-demographic characteristics of the spouses involved (sex, age, nationality, number of children), on the type of separation or divorce (by mutual agreement or contentious) and on other variables of social interest associated with the judicial process (alimony, custody, duration of the proceedings, etc.).

Type of operation: annual continuous statistical operation.

**Population scope**: sentences, decrees and public deeds handed down on annulments, separations and divorces.

**Geographical scope**: the entire national territory.

Reference period for the results: the calendar year.

**Information reference period:** the date on which the sentence, decree or public deed of the dissolution of the marriage takes place.

Collection method: statistical form based on an administrative act.
