Industrial Companies Survey 2006. Definitive data

The net turnover of industrial companies increases 8.9% in 2006

Cataluña, Madrid, Comunitat Valenciana, Andalucía and País Vasco contribute 65.5% of the total turnover

The net amount of turnover of industrial companies rose to 588,384 million euros in 2006, indicating an increase of 8.9% as compared with the previous year.

Sales of industrial products accounted for 485,413 million euros, with an increase of 8.4% as compared with the previous year. Sales of merchandise rose to 74,328 million euros (12.2% more than in 2005), whereas provision of services totalled 28,644 million euros (with an increase of 8.9%).

The number of persons employed in industry in 2006 was 2,623,830, that is, 0.4% less than in 2005.

Operating income structure

On analysis of the structure of operating income, one could observe that product sales represented most of the income (81.1%). This was followed by sales of merchandise (standing at 12.4%) and provision of services (standing at 4.8%).

Operating cost structure

In the cost structure, consumption of raw materials represented 44.5% of companies' total operating costs. Following in second and third places were staff costs (14.5% of the total) and external services (14.3%).

Results by activity group

The activity groups recording the highest increases in their own turnover in 2006 as compared with 2005 were *Metallurgy and manufacture of metallic products* (which underwent an increase of 16.6%) and *Electrical, electronic and optical material and equipment* (15.3%).

The activity groups with the greatest contribution to total turnover were *Food, beverages and tobacco* (representing 15.4% of the total), *Metallurgy and manufacture of metallic products* (representing 13.1%) and *Transport equipment* (representing 12.0%).

Results by activity sectors

The results of the Survey were published for 100 activity sectors, with industry contributing most to the total turnover for *Production and distribution of electricity* (7.6%), *Manufacture of motor vehicles* (6.9%) and *Oil, natural gas and nuclear fuel industry* (6.8%).

Industrial turnover for the 20 sectors with the highest turnover is shown in the following table, indicating the percentage of participation of each of the aforementioned sectors in the total turnover.

Results by Autonomous Community

Cataluña (24.0% of the total), Comunidad de Madrid (11.6%), Comunidad Valenciana (10.3%), Andalucía (10.1%) and País Vasco (9.5%) were the Autonomous Communities that contributed the most to industrial sector turnover. These five Autonomous Communities represented 65.5% of industrial sector turnover.

Results by company size

By analysing the industrial business structure by company size (expressed as the number of employed persons in the company), we note that the total number of companies with 100 or more employed persons generated 65.3% of the total industrial turnover. This percentage decreased to 29.5% if all companies with more than 1,000 employees were considered.



B. Results for all companies with 20 or more employees


Destination of sales (companies with 20 or more employees)

Sales made within Spain represented 76% of the total, whereas those in European Union countries represented 18%.



Origin of the acquisitions (companies with 20 or more employees)

20% of purchased raw materials, merchandise, ... originated in European Union countries, and 17% from countries outside the European Union. Purchases within Spain represented 63% of the total.



Investment (companies with 20 or more employees)

Total industrial investment represented 28,764 million euros, of which 39.7% corresponded to *Technical facilities*, 23.4% to *Machinery and tools* and 16.8% to *Intangible assets*.
