Preview of the Municipal Register at 1 January 2010 Provisional data

The population registered in Spain increases 0.4% and exceeds 46.9 million persons at 1 January 2010

The number of foreign nationals registered stands at 5.7 million, of whom 2.3 million are EU citizens

At 1 January 2010, the total number of residents in Spain was 46,951,532 inhabitants, according to the preview of the Municipal Register, indicating an increase of 0.4% (205,725 persons), as compared with the data from 1 January 2009.

Out of this total, 41,242,592 were persons with Spanish nationality and **5,708,940 were foreign nationals, representing 12.2% of the total number registered**.

The figures published today shall be provisional. The final figures, once the procedure for obtaining them has been finalised, and on receipt of a favourable report from the Registration Council, shall be submitted to the National Government prior to the end of the year, for its approval by Royal Decree, which shall be published in the Official Spanish Gazette.

During the year 2009, the number of registered Spaniards experienced a net increase of 145,456 persons (0.4%) and the number of registered foreign nationals increased by 60,269 persons (1.1%). Of the latter, those belonging to the EU-27 increased by 73,289 (reaching a total figure of 2,346,515 persons), whereas the non-community citizens decreased by 13,020 persons (reaching 3,362,425).

Population by sex and age

49.4% of the total number of registered persons were male and 50.6% were female, according to the provisional data at 1 January 2010. Among the Spaniards, there were more females (51.0%), while among the foreign nationals, there were more males (52.5%).

By **age**, 15.6% of the population was under 16 years of age, 42.6% was between 16 and 44, and 41.8% was 45 years old or older.

By nationality, worth noting was the difference in the group aged 16 to 44 years old. Thus, while the registered Spaniards this age represented 39.9% of the total, this percentage reached 62.0% in the case of the foreign nationals.

Data by Autonomous Community

The Autonomous Communities that registered the greatest increases in population in absolute terms between 1 January 2009 and 1 January 2010 were Comunidad de Madrid (with 58,567 persons), Andalucía (50,920) and Cataluña (29,461).

In contrast, three Communities experienced a decrease in population: Castilla y León (-7,806 persons), Principado de Asturias (-1,180 persons) and Aragón (-54 persons).

In relative terms, the greatest increases in population were produced in Melilla (3.5%) and Ceuta (2.4%), as well as in Región de Murcia, Comunidad de Madrid, Comunidad Foral de Navarra and Illes Balears (all with 0.9%).

The greatest decrease in relative terms was recorded in Castilla y León (-0.3%).

Distribution of foreign citizens by Autonomous Community

The proportion of foreign citizens over the total population residing in Spain stood at 12.2% according to the provisional data of the Register at 1 January 2010.

The Autonomous Communities with the highest proportions of foreign nationals were Illes Balears (21.9%), Comunitat Valenciana (17.3%) and Comunidad de Madrid (16.6%).

In turn, those with the lowest proportions of foreign nationals were Extremadura (3.5%), Galicia (3.9%) and Principado de Asturias (4.5%).

The Autonomous Communities producing the greatest increases in foreign nationals in absolute terms during the year 2009 were Andalucía (23,195), Comunidad de Madrid (7,489) and País Vasco (6,364).

Conversely, the number of foreign nationals decreased in Comunitat Valenciana (-4,718), La Rioja (-589), Aragón (-123) and Castilla y León (-44).

In relative terms, the greatest increases in foreign population were produced in the autonomous cities of Melilla (16.8%) and Ceuta (12.5%), and in País Vasco (4.8%).

The greatest decreases were recorded in La Rioja (-1.3%) and Comunitat Valenciana (-0.5%).

Distribution of foreign citizens by nationality

Release

The foreign nationals residing in Spain and belonging to the EU-27 reached 2,346,515. Worth noting among these were the Rumanian citizens (829,715), followed by those from the United Kingdom (387,226) and Germany (195,579).

Among the group of non-European-Union foreign nationals, Moroccan citizens were the most numerous (746,760), followed by Ecuadorians (395,069) and Colombians (289,296).

In 2009, the number of Rumanian citizens was the figure that experienced the most substantial growth in absolute terms, with an increase of 30,823 persons. Other important growth was recorded in the number of Moroccan citizens (28,705 more), British citizens (11,523) and Chinese citizens (9,128).

Conversely, the greatest decreases were recorded among citizens from Ecuador (26,357 fewer), Bolivia (20,079) and Argentina (11,713).

The greatest relative increases, among the nationalities with the highest number of registered persons, corresponded to Senegalese citizens (8.5%), Chinese citizens (6.2%) and Italian citizens (5.0%).

By groups of countries, the EU-27 citizens were the most numerous, representing 41.1% of the total foreign citizens, followed by citizens from South America, who accounted for 26.6% of the total foreign nationals.

In terms of distribution by sex within the foreign group, the proportion of females was greatest among Latin American nationals. In turn, there were more males in most of the African and Asian nationalities.
