Annual Services Survey Statistics on Products in the Services Sector Year 2010

Turnover in the Services sector increases 0.8% in 2010, standing at 404,605 million euros

The number of companies decreases 1.9%, and employment falls 1.2% as compared with the previous year

The main clients of *Legal activities* are Business services and Services to households

Turnover of companies in the Services sector, excluding Trade, reached 404,605 million euros in 2010, for an increase of 0.8% as compared with the previous year.

The number of companies in the sector decreased 1.9%, and employed personnel fell 1.2%, as compared with 2009.

Results by group of activity

The activity groups registering the greatest increases in turnover in 2010 were *Real estate activities* (6.0%) and *Transport and storage* (5.0%). The latter accounted for a quarter of total turnover for the Services sector.

23.4% of the total employed persons were found in *Accommodation*, and 23.1% were found in *Administrative and support services activities*.

It was worth noting that half of the companies in the Services sector were *Accommodation* and *Professional, scientific and technical activities*. Their contribution to total turnover was 33.6%.

Results by activity sector

On a more broken down level, the activity sectors with the greatest contribution to total turnover in the year 2010 were *Land transport and transport via pipelines* (11.3%), *Food and beverage services* (10.3%), *Storage and activities connected to transport* and *Telecommunications* (both with 9.6%).

Storage and activities connected to transport (9.4%) and Employment-related activities (7.0%) accounted for the greatest annual increases in turnover.

In contrast, the activity sectors registering the greatest decreases in turnover were the Repair of computers and personal and household goods (–10.4%), Office management activities (–5.5%) and Radio and television programming and broadcasting activities (–5.2%).

Employment

78.6% of those employed in the Services sector worked as wage earners in 2010. In companies with fewer than two employed persons, this percentage was 9.9%.

72.5% of wage earners were in permanent employment. In *Legal and accounting activities* and in *Telecommunications*, permanent employment reached the highest percentage (in both cases, 92.7%).

By sex, 45.1% of employed persons were women. Land transport and transport via pipelines (9.5%) and Security and investigation activities (17.8%) were the sectors where the lowest percentages were registered.

In contrast, 84.6% of those employed in *Hairdressing and other beauty treatments* were women. In companies with more than 99 employees, almost half of the workers were women (49.4%).

Investment

Investment in tangible fixed assets totalled 35,825 million euros in 2010, that is, 5.8% less than the previous year. 35.2% of this figure corresponded to *Constructions, building refurbishment, and technical installations.*

Results, according to company size

Nine out of 10 companies had fewer than five employed persons in 2010. These companies invoiced 20.9% of the total for the Services sector, and employed 31.6% of the employed persons.

In turn, companies with more than 99 employees, representing 0.3% of the total, accounted for 44.1% of turnover, and 34.9% of employment in the sector.

Results by Autonomous Community

The Autonomous Communities with the greatest participation in turnover for the Services sector in the year 2010 were *Comunidad de Madrid* (with 32.9% of the total), *Cataluña* (19.4%) and *Andalucía* (9.8%).

In turn, Cantabria, Extremadura and La Rioja had a participation below 1% in turnover for the sector.

Statistics on Products in the Services Sector

These statistics enable us to ascertain the activity sectors to which the different services are rendered. According to the results corresponding to the year 2010, the three main clients of Professional, scientific and technical activities were Industry (20.8%), Business services (18.8%) and Trade (11.4%).

Within this group, the main clients of *Legal activities* were Business services (22.7%) and Households, accounting for 18.2% of their turnover.

Technical architecture and engineering services companies worked mainly for Industry (31.1%), whereas, among Advertising companies, Trade accounted for a quarter of their turnover.



Employees requested from Temporary Employment Agencies (ETT) in the year 2010 were, by order of preference, supplied for jobs in industry (42.2% of the total number of hours invoiced) and office staff (16.7%).

Personnel supplied to accommodation and to trade represented 7.5% and 7.2% of the hours invoiced by ETTs, respectively.

Considering the breakdown of turnover for each sector, by the different products they offer, it was worth noting that the products generated the greatest turnover of *Technical architecture* and engineering services companies were engineering projects for industry (16.1%), engineering advisory and consultancy (13.9%) and energy projects (11.5%).

Methodological note

The Annual Services Survey, which is structural and annual, targets companies dedicated to Transport and storage, Accommodation, Information and Communications, Real estate activities, Professional, scientific and technical activities, Administrative and support services activities and Repair activities.

Arts, recreation and entertainment activities and Other personal services are partially included each year alternately, by means of a rotation system. Artistic and showbusiness activities, Library, archive and museum activities and other cultural activities and Hairdressing and other beauty treatments have been included in the Survey for the year 2010.

Associative Activities, Education and Health Activities and Market Social services and Financial and Insurance activities are excluded from the scope of this Survey.

This operation makes it possible to ascertain the specific structural and economic features of each activity included in the sphere of study, such as company size, accounting data (purchases, expenditure, capital movements) and employment and investment structure.

The Annual Services Survey is aimed at a sample of approximately 82,000 units, selected from a population of around 1,300,000 companies, and makes it possible to obtain representative results, at a detailed activity level, by Autonomous Community, and by company size, according to the number of employed persons.

Statistics on Products in the Services Sector is an operation of a structural nature and is published annually, integrated into the previous one, the fundamental objective of which is to provide a detailed breakdown of turnover, for the majority of activities, by products sold by companies dedicated to the Services sector, as well as the activity sector of the client.

Other variables studied in this survey are the breakdown of supplies and of the vehicle pool or fleet in Transport, the breakdown of purchases in Hotels and Travel agencies, personnel by professional category, sex and main activity in IT activities or the number of hours invoiced according to the type of staff in Employment-related activities.
