## Elections to the Parliament of País Vasco on 21 October 2012

# The Electoral Census Office accepts 97.1% of the claims filed by voters

# Applications to vote are processed for 11.2% of the Electoral Census of Absent Residents

In the periods set out in the Organic Law on the General Electoral Scheme, the Electoral Census Office (ECO) has carried out the actions listed below in the elections to the Parliament of País Vasco on 21 October 2012.

Regarding polling stations and electoral premises, the ECO established the 2,778 polling stations and 758 electoral premises, at the proposal of the municipal councils.

Moreover, it sent the Municipal Councils and consulates the electoral census in force for voter query.

The ECO resolved and sent notification on 240 claims submitted to the electoral census query. 97.1% of those claims were accepted, while the rest were refused.

Once this claim process was complete, the ECO proceeded with publishing and distribution of the voting lists and the certifications to candidates and scrutineers.

#### Postal vote

The ECO processed the postal vote for those voters registered in the Electoral Census of residents in País Vasco. A total of 46,105 applications were accepted, accounting for 2.7% of the total voters.
